Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mr.Suresh Kumar Balakrishnan and Mrs.Sreelakshmi P S availed HL NRI 7281573231, HL NRI 7316900072 facilities from Indian Bank, M G Road, Ernakulam Branch and Mr.Suresh Kumar Balakrishnan is the mortgagor who has offered their assets as security to the loan, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Suresh Kumar Balakrishnan and Mrs.Sreelakshmi P S has failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.11.2024 (published in newspaper on 19.11.2024) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr.Suresh Kumar Balakrishnan and Mrs.Sreelakshmi P S liable to the Bank, to pay the amount due to the tune of Rs. 74,83,929/- (Rupees Seventy Four Lakh Eighty Three Thousand Nine Hundred and Twenty Nine only) (Rs.64,55,042.00 for HL NRI-FO21-CBL UPTO 700: 7281573231 and Rs. 10,28,887.00 for HL NRI-FO21-CBL UPTO 700: 7316900072) as on 05.11.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.11.2024.

Mr.Suresh Kumar Balakrishnan and Mrs.Sreelakshmi P S failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 20.01.2025 after complying with all legal formalities.



As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 02.06.2026 is **Rs. 89,53,060/- 82,99,922/- (Rupees Eighty Nine Lakh Fifty Three Thousand and Sixty only) (Rs. 77,58,848/- for HL NRI 7281573231 and Rs. 11,94,212/- for HL NRI 7316900072)** with further interest, costs, other charges and expenses thereon from 03.06.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 24th June 2026 which would be by e-auction mode.
