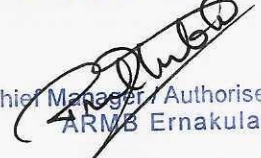

borne by the purchaser.

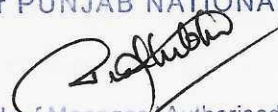
