

Philippine senator wanted by ICC flees from Senate

MANILA: A Philippine senator wanted by the International Criminal Court for an alleged crime against humanity has fled from the Senate, where he sought refuge to evade arrest, officials said Friday.

Sen Ronald dela Rosa's exit from the heavily guarded Senate came after volleys of gunshots were fired Wednesday night by the building's security personnel during an argument with gov-

ernment agents positioned in an adjacent building, sparking chaos that apparently helped the senator to slip out. President Ferdinand Marcos Jr made a late-night TV statement to ask the public to remain calm.

A police investigation was underway, including into suspicions that the incident was instigated to provide dela Rosa a cover to escape. "There is no obstruction of justice," Senate President Alan Cayetano said of dela Rosa's escape while in the Senate's protective custody. He told a news briefing that he did not see any ICC warrant of arrest against dela Rosa and the senator was free to leave the premises. AGENCIES

THE WARRING SIDES AGREED TO A CEASEFIRE BROKERED BY PAKISTAN

Ceasefire with Iran a 'favour' to Pakistan: US Prez Trump

WASHINGTON: US President Donald Trump on Friday said he agreed to a ceasefire with Iran as a "favour" to Pakistan and ruled out any further bombing of the Persian Gulf nation, with which it has been at odds for several decades.

The US and Israel's war on Iran started on February 28, and attacks have been paused since April 8, when the warring sides agreed to a ceasefire brokered by Pakistan.

"We did the ceasefire as a request from another nation. I would have really benefited from it, but we did it as a favour to Pakistan. They are terrific people, the Field Marshal and the Prime Minister," Trump told reporters on Air Force One while returning from China to the US. Trump reiterated his resolve not to allow Iran to acquire nuclear weapons and to make them give up the enriched uranium Tehran has accumulated over the years. He said the Iranian nego-

tiators were claiming that their nuclear facilities were damaged in the American air strikes and that they were not in a position to retrieve the nuclear fuel.

"They came up with a terrible secret. They said that they

can't remove it because they don't have the technology to remove it. They don't have the time and the practice," Trump said in response to questions on Iran. Trump said Chinese President Xi Jinping was also

in favour of opening up the Strait of Hormuz, which is a key trade route for 20 per cent of the global oil supplies.

US Vice President J D Vance-led a team of negotiators for the first-ever direct face-to-

face talks with Iranian leaders in Islamabad on April 11-12, which got the warring nations into prolonged negotiations to end the decades-long hostilities.

The US has been insisting that Iran give a clear commitment to end its uranium enrichment programme in exchange for the lifting of sanctions and the release of billions in frozen Iranian funds. AGENCIES

Hinduja family tops UK's rich list under next-gen brothers

LONDON: The Hinduja family retained their top spot as the UK's richest family in the 2026 'Sunday Times Rich List', released on Friday, under a new generation of brothers following the death of Gopichand Hinduja last year.

"Sanjay and Dheeraj Hinduja and family" emerged as the UK's richest for the fifth successive year with an estimated 38 billion pounds, up from last year despite global headwinds. The Hinduja Group operates in 38 countries with investments across several sectors, including mobility, digital technology, banking and financial services, media,

project development, lubricants and specialty chemicals, energy, real estate, trading, and healthcare.

"The death of their father, Gopi Hinduja, at the age of 85 last November has handed his place at the top of the 'Sunday Times Rich List' to his London-based sons, Sanjay and Dheeraj," the newspaper notes.

"Sanjay, 62 this month, chairs Gulf Oil International while Dheeraj, 54, oversees the automotive giant Ashok Leyland. The latter has had a strong year, with the share price soaring by almost 40 per cent as more Indian motorists transition to electric vehicles.

"Indusind, the Mumbai-based banking and financial services group, has also had a decent 12 months. The shares here are up 14 per cent since last year," it states.

Besides the Hinduja family, the top 10 of the annual tally of the UK's richest sees another set of Indian-origin brothers, David and Simon Reuben, hold onto their wealth at second place with an estimated 27.97 billion pounds. "The India-born brothers are close to completing two vast renovations of historic London buildings, Admiralty Arch and Cambridge House, which are being transformed into luxurious hotels," the newspaper reveals.

While textiles entrepreneur Prakash Lohia has climbed a few spots to 28th with around 6.44 billion pounds, Vedanta Resources' industrialist Anil Agarwal has dropped to 43rd from last year's 25th with an estimated 3.85 billion pounds. AGENCIES
