Police question Swastika over her 2021 poll tweets

BENGAL FILM star Swastika Mukherjee was questioned by the police on Saturday in connection with a case filed against her and actor Parambrata Chatterjee over their purported social media posts following the declaration of the West Bengal poll results in 2021, officials said.

Mukherjee was questioned for nearly an hour at the Garhi police station in south Kolkata, she said.

The complaint was lodged on May 21 by an advocate, alleging that social media remarks made by the two actors after the 2021 election results had contributed to an atmosphere that fuelled violence in the state.

Man who sold jhalmuri to PM gets death threats; security tightened at stall

ON RECEIVING A complaint of death threats, Jhargram police have provided security to Bikram Kumar Sahu, who shot to limelight after Prime Minister Narendra Modi bought jhalmuri from his stall during the election campaign in West Bengal.

Sahu has complained to the police that he has received "repeated death threats" through text and WhatsApp app messages from Pakistan and Bangladesh.

"A complaint has been filed. While all aspects of security are being examined, an investigation has also been initiated in view of the seriousness of the complaint," a police officer involved in the probe said, adding

cybercrime experts have also been roped in. "Efforts are underway to identify the phone numbers through which the threat calls were made," the officer said. Meanwhile, police and CAP personnel in uniform, as well as in plainclothes, have been deployed at the stall. CCTV cameras have been installed. "My family members were also scared, and I had shut the shop for a few days," Sahu said after he reopened the stall.

Proceedings begin against suspended RG Kar doctor

Kolkata: The state government on Saturday initiated departmental proceedings against a doctor suspended following the rape and murder at RG Kar Medical College and Hospital, and also ordered a separate enquiry into his admission to a postgraduate course.

According to a notification issued by the Health and Family Welfare Department, proceedings have been initiated against Dr Avik De, former resident medical officer (RMO) of Radio-diagnosis Department at Burdwan Medical College and currently an in-service OC trainee in General Surgery at IPGME&R, Kolkata. Governor NR Ravi granted approval for the initiation of departmental proceedings against the doctor. PTI

TMC councillor found dead; police say prima facie suicide

Party says he was receiving threats, seeks fair probe

A TMC councillor from South Dum Dum Municipality was found hanging in his home in north Kolkata on Saturday, said police. Sanjay Das, 50, represented Ward Number 18 and was considered very influential in the South Dum Dum area.

According to police, family members grew suspicious when he did not come out of his room Saturday morning, and after breaking open the door of his room, he was found hanging. Das was taken to a private hospital

tal in Nagerbazar, where doctors declared him dead on arrival.

Sources in the police said prima facie, it looked like a case of suicide, but added that no suicide note was recovered. A case of unnatural death has been registered at the local Nagerbazar police station. "We are investigating the case, and all possible angles are being looked into," said a police officer. Das was considered to be

close to another TMC councillor from the area, Debaraj Chakraborty. Debaraj, who is married to former TMC MLA Aditi Munshi, is being investigated by Central agencies in connection with alleged irregularities in the recruitment process carried out by the civic body.

On Friday, the couple had moved the Calcutta High Court seeking anticipatory bail in a disproportionate asset case filed by the Bidhanagar City Police.

Several TMC councillors, believed to be close associates of Chakraborty, have been arrested over the past few days in cases involving extortion, assault, and intimidation.

Former TMC minister Sujit Bose was arrested by the Enforcement Directorate on May 11 in connection with the recruitment scam at the South Dum

Dum Municipality and was slapped with a money laundering case. Former chairperson of the TMC-run civic body, Panchu Roy and former Food Supplies Minister Rathin Ghosh have also been questioned.

Meanwhile, TMC leaders attributed Das' death to "pressure and threats" that was allegedly receiving. "It is a sad incident. We hope that the police will thoroughly investigate the matter. We are hearing that he committed suicide. There were no allegations of extortion or corruption against him. But locals said that after the elections, he was getting extortion calls, and when he refused to give money, they tried to blackmail him and ruin his image. He was under tremendous mental stress as he was getting threats," TMC spokesperson Kunal Ghosh said.
