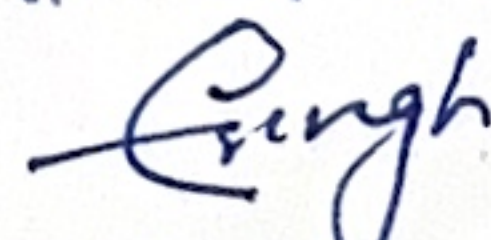

- 22) Date & time of inspection of Property : 10.06.2026 To 15.06.2026 – 10: 00 A.M to 5: 00 P.M(All Working Days).
- 3) Date and time of auction: 16.06.2026 between 11:00 A.M. to 05:00 P.M. as per (IST)
- 4) Auction would be conducted for an initial period of 360 minutes followed by unlimited extensions of 10 minutes each, in case a valid bid is received in last 10 minutes.
- 5) Auction would commence at Reserve price, as mentioned above. Bidders shall improve their offers in multiples of **Rs. 10,000/- (Ten Thousand only)**
- 6) Intending bidder shall register with the E-AUCTION portal to create their user-ids and passwords. 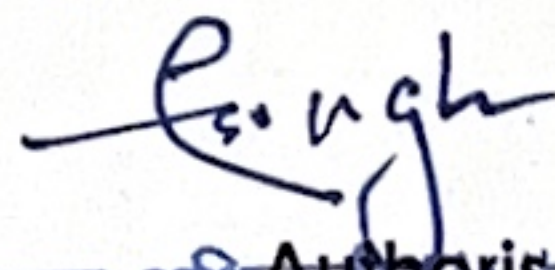
