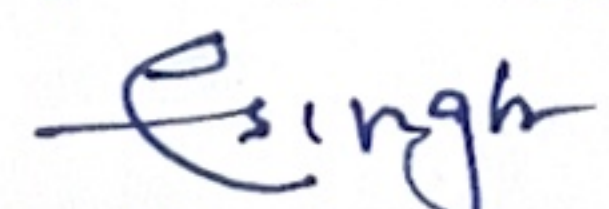


PUBLIC NOTICE OF E-AUCTION SALE (FOR IMMOVABLE PROPERTY)

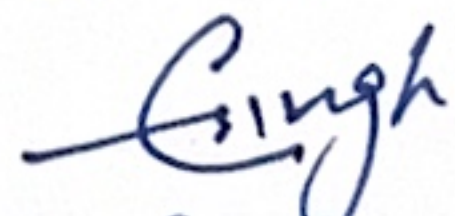

- 4) Auction would be conducted for an initial period of 360 minutes followed by unlimited extensions of 10 minutes each, in case a valid bid is received in last 10 minutes.
- 5) Auction would commence at Reserve price, as mentioned above. Bidders shall improve their offers in multiples of **Rs. 10,000/- (Ten Thousand only)**

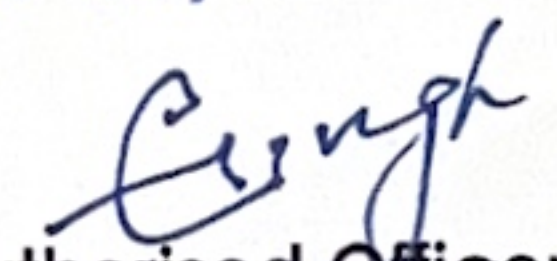
SPECIAL INSTRUCTION/CAUTION
