Shri Anuj Sharma & Smt Sandhya Sharma, availed **50313771477 (TL)**, facility from Indian Bank, Dayalbagh Branch and, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **Shri Anuj Sharma & Smt Sandhya Sharma** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 25.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), **Shri Anuj Sharma & Smt Sandhya Sharma, Account No.: 50313771477 (TL)** liable to the Bank to pay the amount due to the tune of is **Rs. 26,99,936 (Rupees Twenty-Six Lac Ninety-Nine Thousand Nine Hundred Thirty-Six only)** as on 25.11.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 25.11.2025.

As Shri Anuj Sharma & Smt Sandhya Sharma (Borrowers), Home Loan Account No.: 50313771477 (TL) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 13.02.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
