# Teen Andreeva overcame inner demons to lift title

Bent over with her hands covering her face, her knees getting dirtied on the red clay court, Mirra Andreeva was celebrating, processing might be the more appropriate word, how she had finally overcome "so many demons inside" that came with being a teenage tennis phenom. After bursting onto the scene at 15, Andreeva became a Grand Slam champion at 19 when the Russian ended the run of 114th-ranked Polish qualifier Maja Chwalinska with a 6-3, 6-2 victory in the French Open final on Saturday.

"I've done a lot of visualizations before. Not just this tournament, but I've had dreams, I've had a lot of thoughts on how it's going to happen, if it's going to happen, when it's going to happen, where," Andreeva said, still hardly breathing as she talked quickly in true teenage style. "The feeling in real life is so

much better than in your dreams. "I can call myself a Grand Slam champion," Andreeva added. The biggest challenges for Andreeva have not been on the court, she already has one of the best attacking baseline games in the sport, it's been the mental side. And her stubbornness.

"Her attitude is difficult," said Conchita Martinez, Andreeva's coach and a former Wimbledon champion. "You tell her something, and maybe she's not open to listening. ... When she works hard and when she listens and she does everything, she has no limits." Andreeva said.

## Zverev-Cobolli battle hard in the men's final

Chasing an elusive Grand Slam title, Alexander Zverev was challenged well by 14th-ranked Italian Flavio Cobolli in the men's final on Sunday.

It's the fourth major final of Zverev's career and it was a unique opportunity for the third-ranked German without Jannik Sinner or Carlos Alcaraz across the net.

Zverev took the first set but Cobolli fought back to take the second. The German roared back again to bag the third set. The fourth set went into the tie-break and Zverev had slender lead, before a pumped up Cobolli leveled the match with stunning display. At the time of going to press, both players were level on 2-2 (6-1, 4-6, 6-4, 6-7(5)).

# Mumbai Falcons storm into women's final; Tigers win

SOBO Mumbai Falcons sealed their place in the final of the inaugural Nuvama Private T20 Mumbai Women's League after registering their third successive victory with a comprehensive 39-run win over Aakash Tigers Mumbai Western Suburb at the Wankhede Stadium in Mumbai on Sunday.

Defending a competitive total of 143/7, the Falcons produced a clinical bowling display to dismiss the Tigers

for 104 in 18.2 overs. The chase got off to the worst possible start for the Tigers as skipper Humairaa Kaazi was dismissed for a duck by her opposite number Sayali Satghare before the team could open its account. Opener Sanika Chalke and Sejal Raut attempted to rebuild the innings with a 47-run partnership for the second wicket.

Once Sanika departed, the Tigers struggled to keep pace with the required rate as wickets fell regularly. Sayali led (2/21) from the front with the ball, while Nirmiti Rane

(2/21) and Swara Jadhav (2/12) chipped in with two wickets apiece.

Earlier, Sarika Koli's composed 49 laid the foundation for the Falcons' total. Simran Shaikh (38) and Aarohi Bambode (19) laid the platform with a valuable 44-run stand.

Koli then took charge alongside captain Sayali, adding 43 runs for the fourth wicket. However, Fatima Jaffar, who impressed with figures of 3/20, broke the partnership. Koli anchored the innings, ensuring the Falcons posted 143/7.
