Ms. VIDHI CHETANKUMAR PANDYA availed HL facility from Indian Bank, Dahisar East Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Ms. VIDHI CHETANKUMAR PANDYA failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 10.03.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Ms. VIDHI CHETANKUMAR PANDYA liable to the Bank to pay the amount due to the tune of Rs.17,23,457/- (Rupees Seventeen Lakhs Twenty Three Thousand Four Hundred Fifty Seven Only) as on 10.03.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 10.03.2023.

As Ms. VIDHI CHETANKUMAR PANDYA failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 17.05.2023 after complying with all legal formalities.

As per Sec. 13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode
