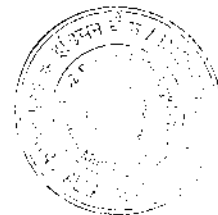
Mr. Pramod Pandurang Mahadeshwar availed HL-ADVTGE-RESFLOT75L MCLR from Indian Bank, Kandivali East Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Pramod Pandurang Mahadeshwar failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 30.09.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr. Pramod Pandurang Mahadeshwar to the Bank to pay the amount due to the tune of Rs. 1321386.91/- (Rupees Thirteen Lakh Twenty One Thousand Three Hundred Eighty Six and Paise Ninty One Only) as on 28.09.2022 with further interest, costs, other charges and expenses thereon. You failed to make payment despite Demand Notice dated 30.09.2022.

Mr. Pramod Pandurang Mahadeshwar failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 01.02.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.

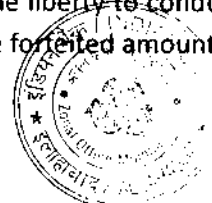
The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefor.
