Mr.Sadhu Charan Panigrahi and Mr. Jitendra Kumar Panigrahi availed Home Loan and Vehicle Loan facilities from Indian Bank, Sonepur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Sadhu Charan Panigrahi and Mr. Jitendra Kumar Panigrahi failed to pay the outstanding dues to the Bank.

Therefore, a Demand Notice dated 26.06.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr. Sadhu Charan Panigrahi and Mr. Jitendra Kumar Panigrahi Borrower (s), liable to the Bank to pay the amount due to the tune of Rs.33,74,778/- (Rupees Thirty Three Lakh Seventy Four Thousand Seven Hundred and Seventy Eight Only) as on 25.06.2024 with further interest, costs, other charges and expenses thereon. He failed to make payment despite Demand Notice dated 26.06.2024.

As Mr. Sadhu Charan Panigrahi and Mr. Jitendra Kumar Panigrahi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 17.09.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 25.06.2024 is of Rs.33,74,778/- (Rupees Thirty Three Lakh Seventy Four Thousand Seven Hundred and Seventy Eight Only) with further interest, costs, other charges and expenses thereon from 26.04.2024.

If the e-auction fails owing to any technical snag etc., the same may be re-scheduled by issuing 7 days' prior notice.

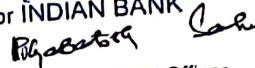

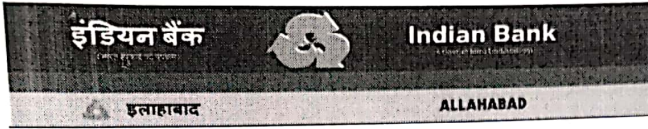
