

Sharmila fails to figure in Cong RS list

THE Congress party in Karnataka has announced its formal list of Rajya Sabha nominees, naming Mallikarjun Kharge, Mansoor Khan, and Pawan Khera. The updated list drops Andhra Pradesh Congress Committee president Sharmila Reddy, who was mentioned in earlier reports.

Chief Minister DK Shivakumar stated that the party would field a fifth candidate for the Legislative Council (MLC) seat. The Congress is short of the required 29 first-preference votes for the seat and lacks a few votes to secure it on its own.

Karnataka to set up NRI Secretariat

CM DKS says NRI Secretariat will engage with overseas Indians and promote investments

CHIEF Minister DK Shivakumar on Thursday announced that the government will establish separate secretariats for public grievances and Non-Resident Indians (NRIs). A dedicated minister will hear complaints and demands from people visiting Bengaluru, while the NRI Secretariat will facilitate engagement with overseas Indians and promote investments in Karnataka, he said.

Officials concerned have been directed to frame the necessary legislation for the initiative, the chief minister said.

Speaking to reporters after he held a meeting with senior officials, Shivakumar said a separate secretariat will be established to hear and address public grievances, particularly those of people staging protests and demonstrations in Bengaluru and other parts of the State.

The chief minister also said several groups approach the government every day with various demands and issues, and their grievances must be heard. He said the facts behind their demands shall be verified and a prompt response will be

provided. There is a need for a dedicated secretariat to hold discussions with the representatives of protesting groups and facilitate timely resolution of their concerns, he said.

On the proposed NRI Secretariat, Shivakumar said, "I have directed officials to frame appropriate legislation to facilitate engagement with Indians living abroad and to encourage NRI investments in Karnataka.

The proposed secretariat will serve as a dedicated platform to support overseas Indians and

promote investment opportunities in the State." Stressing on Corporate Social Responsibility (CSR) funds in Karnataka, the CM said there is nearly ₹8,000 crore available under CSR funds in the State.

However, there is no information which organisations are utilising these funds and for what purposes. "Therefore, companies must inform the government about the utilisation of CSR funds in Karnataka," he said.

Shivakumar said his disposition has already initiated the construction of Karnataka Public Schools under CSR funding, with one school for every three gram panchayats.

Sudanese national under observation amid Ebola scare

A 35-year-old Sudanese national was placed under observation in an isolation ward at Gandhi Hospital on Thursday after routine thermal screening at the Rajiv Gandhi International Airport (RGIA), Hyderabad, detected a fever.

According to an airport official, the traveller had recently visited Uganda and South Sudan and had arrived in the city for a scheduled knee surgery.

During routine thermal screening at RGIA, he recorded a temperature of around 100°F, following which airport health officials alerted the State's medical response team.

The individual was subsequently shifted to Gandhi Hospital, Telangana's primary nodal centre for Ebola preparedness.

Talking to *TNIE*, Dr Vamsi Krishna, nodal officer for Ebola preparedness at Gandhi Hospital, said, "The passenger was shifted to a separate isolation room as a precautionary measure following the airport screening. Medical teams have collected blood samples, urine samples and swabs for laboratory testing. The samples have been sent to the Centre for Cellular and Molecular Biology (CCMB) and we are awaiting

for the report. If the findings are positive or raise any suspicion, the samples may be forwarded to the National Institute of Virology (NIV), Pune, for further confirmation."

He said the individual is currently stable and has not exhibited fever or any other symptoms since admission.

The nodal officer also emphasised that no conclusions can be drawn until the test results are received. "The patient is asymptomatic and under observation. It may not necessarily be a serious infection; it could be something else. We are conducting routine investigations and will decide the course of treatment after receiving the reports and also we are trying to obtain detailed medical and travel information from the patient," he added.

One held for stealing 18 hard disks from TNEB HQ

A 31-year-old technician employed by a private firm contracted by the Tamil Nadu Electricity Board (TNEB) was arrested on Thursday for allegedly stealing 18 hard disks containing official data from the TNEB headquarters in Chennai.

Police said they have recovered all 18 hard disks, and further arrests are likely. During interrogation, the accused, identified as Gopinath, alleg-

edly confessed to stealing the hard disks and claimed that he had sold them as scrap at a shop in Bengaluru, police sources said.

Gopinath had been working as a technician at the TNEB headquarters for the last 11 months. He regularly handled the repair and maintenance of computer hardware and software systems.

Addressing reporters in Chennai, Electricity Minister CTR Nirmalkumar said a few

persons linked to the incident were taken to Bengaluru for further investigation. "Efforts are on to ascertain the data stored in those hard disks and to retrieve them through digital backups. We are confident that important records can be restored. No one involved in the offence will be spared. Strict action will be taken against all those found responsible," he added.

According to police sources, the theft occurred last week but

came to light only after hard disks were found missing from computers at the headquarters. While at least 18 hard disks were allegedly stolen, departmental authorities lodged complaints regarding 14 missing units on June 2.

Following complaints from TNEB officials, the board's vigilance wing initiated a preliminary inquiry and alerted the police. Based on the complaint, the Chennai police formed multiple special teams on the directions of the city police commissioner to investigate the case.
