M/s ARSHI SEA FOODS, Prop-Mr. Nazeeruddin Sheik (Borrower cum proprietor), Mr. Nazeeruddin Sheik (Borrower cum proprietor) S/o Sai Sheik , Mr. Satti Prasada Reddy (Guarantor cum Mortgagor) , S/o Satti Gopala Reddy failed to make payment despite Demand Notice dated 22.01.2026.

As the above parties failed to make payment despite Demand Notice, the Authorized Officer took symbolic/physical possession of the schedule mentioned properties under the Act on 25.03.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 22.01.2026 is Rs 20643665/- (Rupees Two crores six lakhs forty three thousand six hundred and sixty five Only) with further interest, costs, other charges and expenses thereon from 22.01.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 29.06.2026 which would be by e-auction mode.

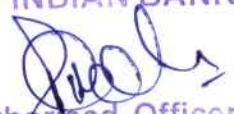
