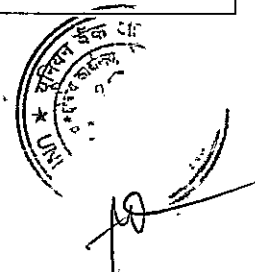
10.6 Steps Involved

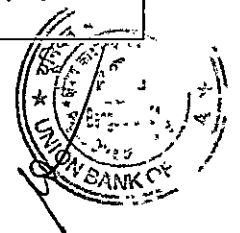

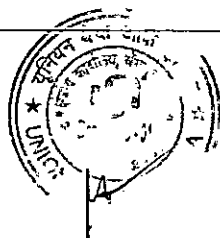
