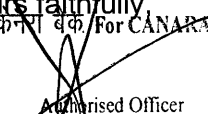

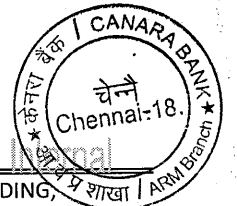

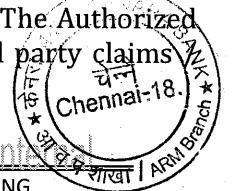

- d. 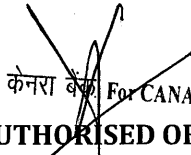
