3. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/bidder-registration> using their mobile number and email-id. They will be provided with user Id and password by the service provider which should be used in the e auction proceeding. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers must transfer the EMD amount using online mode in his Global EMD **Wallet account by 28.06.2026 or, as per the guidelines of the Portal.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider. Bids without EMD shall be rejected summarily.
