NOTICE OF SALE

Notice of sale under Rule 6(2) & 8(6) / 9(1) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mr.Chandaran K and Mrs.Shinimol C A availed Housing Loan facility from Indian Bank, Vadakkenchery Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Chandaran K and Mrs.Shinimol C A failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 13.01.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr.Chandaran K and Mrs.Shinimol C A liable to the Bank to pay the amount due to the tune of Rs.9,27,093/- (Rupees Nine lakhs twenty seven thousand ninety three Only) as on 09.01.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 13.01.2026.

As Mr.Chandaran K and Mrs.Shinimol C A failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 04.05.2026 after complying with all legal formalities

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) & 8(6) of the Security Interest (Enforcement) Rules 2002, 30 days' notice for first sale is required to be given and hence we are issuing this notice.

The amount due as on 04.05.2026 is Rs. 953952/- (Rupees Nine lakhs fifty three thousand nine hundred fifty two Only) with further interest, costs, other charges and expenses thereon from 05.05.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 07.08.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
