Mr.Shuhaib Shahul Hameed ,Mrs.Sabira S H and Mr.Shahul Hameed have availed Home loan facility from Indian Bank, Koorkenchery Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.Shuhaib Shahul Hameed ,Mrs.Sabira S H and Mr.Shahul Hameed failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 27.07.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr.Shuhaib Shahul Hameed ,Mrs.Sabira S H and Mr.Shahul Hameed liable to the Bank to pay the amount due to the tune of Rs. 35,75,921/- (Rupees Thirty five lakhs seventy five thousand nine hundred twenty one Only) and any other dues/charges to be paid to any Govt. Office/Department as on 27.07.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 27.07.2023.

As Mr.Shuhaib Shahul Hameed ,Mrs.Sabira S H and Mr.Shahul Hameed failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 28.11.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.
