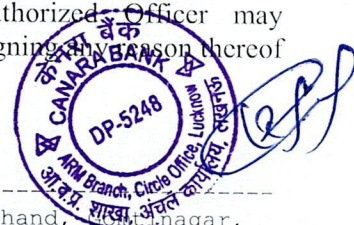

- (Incremental amount/price) mentioned under the column "Increment Combo" (at least select 1).
