

Bargarh, May 21: Police in Bargarh district Thursday arrested a rape accused who had reportedly remained absconding for 16 years.

The accused, identified as Sahadev alias Gangadhar Pandey, 42, of Mahada village under Bhatli police station limits, was produced before a court in Bargarh and later remanded to judicial custody after his bail plea was rejected.

According to police, a woman had lodged a complaint at Bhatli police station April 7, 2010, alleging that Pandey had raped her. A case had been registered under relevant sections of the Indian Penal Code, including rape and cheating.

Police said the accused had been on the run since the incident. Despite repeated efforts, officers were unable to trace him for years. The government had also announced a reward of ₹500 for information leading to his arrest. Police said the victim and her family expressed relief after the arrest of the accused.

Woman strangled to death in sleep

Baisinga: A 50-year-old woman was allegedly strangled to death during her sleep at Ganeshwarpur village under Baisinga police limits in Mayurbhanj district late Wednesday night. The deceased was identified as Anita Singh, wife of late Radhu Singh. Anita lived alone in the village and earned a living by running a small shop in front of her house. Her only son works in Pudukcherry. According to reports, locals who came to the shop Thursday morning found Anita's body lying, naked inside her bedroom and informed police. Baisinga IIC Barini Das, along with a police team, reached the spot and launched an investigation.

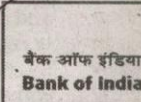
