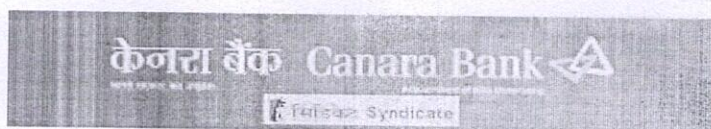

The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs. 4,50,600/- (Rupees Four Lakh Fifty Thousand Six Hundred Only), being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" and provide following details on or before 5.00 p.m. of 14-07-2026

f. Auction would commence at Reserve Price, as mentioned above. Even if there is only one bidder who has submitted EMD against particular property, the said bidder has to bid at least one increment above the Reserve Price in order to become successful H-1 bidder.
