

Missing man found murdered; wife among suspects

Agra: Police have solved the alleged murder of a 35-year-old farmer from Sikhera village in Muzaffarnagar who had been missing since May 18, arresting one accused and naming the

victim's wife and stepson among the suspects. Vikas alias Rocky's wife, Renu (42), and stepson, Badal (25), are suspected of involvement in the conspiracy and execution of the crime, police

said. Both are absconding, and teams have been deployed to trace them. Preliminary probes suggest that a family dispute between Vikas and Badal may have been the motive behind his abduction and murder. DSP (New Mandi) Raju Kumar said, "During interrogation, the arrested

‘Mistakenly’ buried man cremated

Agra: A 32-year-old man from Hathras, whose body was found on May 9 after he went missing on May 4, was cremated as per Hindu rituals 20 days after police found that he was mistakenly identified and buried as a Muslim man who had also gone missing around the same time.

Subhash Kumar, a resident of Loharra village under Sasni police station jurisdiction, went missing after leaving his sister's house for work. The family did not file a missing report, said police.

On May 9, police found an unidentified decomposed body on Iglas road, and it was identified by the family of a local Muslim man as Hashmi

Ahmed, 30, who had gone missing on May 4 from Nagala Garu village. Police handed over the body to the family after a postmortem examination. The body was buried as per Islamic customs.

During investigation, Hashmi's case took a bizarre turn when cops coincidentally approached Subhash's brother-in-law's house on Iglas Road to check CCTV footage. Subhash's sister promptly identified the body as that of their missing brother.

"Investigators came to the conclusion that the body buried in Nagala Garu village was that of Subhash's, not Hashim's," said the Sasni SHO Vipin Chaudhary. A team of police sent to Hyderabad on May 11 confirmed that Hashim was alive and working.

Ex-village head shot dead; poll rivalry suspected

Agra: A 50-year-old former gram pradhan was shot dead and his younger brother injured after armed assailants allegedly opened fire on their car in Agra's Jaipur area on Monday night. Police suspect the attack was linked to a long-standing rivalry stemming from village panchayat elections.

Avneesh Yadav, and his brother, Upendra Yadav, 45, were returning to Jaipur after attending court proceedings in a case related to an ongoing dispute with the family of the current village head, Indraj Yadav.

Family members said the rivalry had become so intense that they were forced to shift from their native village. Avneesh had won the panchayat election in 2016.

Bah ACP Hare Krishna Sharma said the complainant had named gram pradhan Indraj Yadav and several others in the case. "Efforts were underway to arrest the accused," Sharma said. **TNN**
