

Pope slams world’s indifference to migrants

Pope Leo XIV travelled to a once-notorious epicentre of the European migration debate on Thursday, challenging countries to uphold migrants’ rights while shaming those leaders, including Christians, who turn them away with indifference. Leo issued an impassioned plea to recognise the dignity of migrants from the port of Arguineguin, in the Canary Islands. In 2020, the port was dubbed “dock of shame” because of the squalid con-

ditions migrants were forced to live in for months during a spike in arrivals. “Human dignity has no passport and does not lose its value when crossing a border,” Leo said, with rescue ships docked behind him and a simple wooden cross made from a shipwrecked migrant boat nearby. Leo is spending the final two days of his weeklong trip to Spain in the Canary Islands, a Spanish archipelago closer to Africa than the Iberian Peninsula and a key point of entry for migrants who make the perilous Atlantic crossing from West

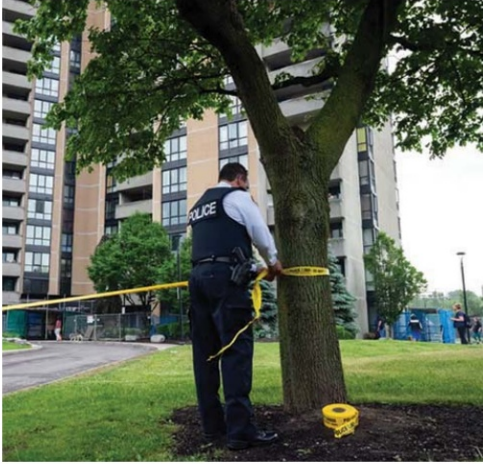

Africa. He was fulfilling a wish of Pope Francis to visit the Canary Islands to commemorate the thousands of lives lost at sea. With two migrants standing by him, Leo threw a bouquet of flowers into the sea. The gesture recalled one Francis made in 2013, at the start of his pontificate, when he visited another migration flashpoint in Lampedusa, Sicily and denounced the “globalisation of indifference” that the world showed migrants. The Canary Islands have long been a stepping stone for migrants trying to reach

Europe from West Africa and Morocco. Some experts consider the Atlantic route they take to get here more deadly than the more well-known central Mediterranean smuggling route from Libya and Tunisia to Italy. Migrant arrivals in the Canary Islands peaked in 2024 at nearly 47,000. Following pressure and deals between the European Union, Spain and the governments of several West African nations, arrivals have fallen dramatically, with just over 3,000 people landing there in the first five months of 2026.

Canadian cop shot dead while probing US consulate attack

A Toronto police officer was shot and killed Thursday by a suspect in the investigation into a shooting attack that damaged the facade of the US Consulate in the Canadian city in March, police said. One suspect was in custody at a hospital while officers searched for a second suspect, who was identified as 19-year-old Zara Jabbi and was considered armed and dangerous, Toronto Police Chief Myron Demkiw said at a news conference. “I urge you to turn yourself in,” Demkiw said. Police officer Marc Pinizotto, who was 43 and had been on the force for 18 years, died of his wounds in a hospital, Demkiw said. Canadian police had said in March that two individuals emerged from a white Honda RV SUV at around 4:30 am

and fired multiple shots at the consulate building before fleeing. The shooting damaged the outside of the building but did not cause any injuries. The consulate attack in March followed heightened tensions over the war launched by the US and Israel against Iran in late February, and it had followed gunfire attacks on two Toronto-area synagogues the previous weekend. The investigation that led to Pinizotto’s death “concerned a number of shootings, including the shooting at the United States consulate on University Avenue. There were several search warrants executed this morning,” Demkiw said. Toronto Mayor Olivia Chow said she’s known the mother of the deceased officer for the 20 years. “Their grief is shared across this city,” Chow said.

India’s missile program has wider ambitions: Pak official

A senior Pakistani defence official on Thursday claimed that India’s long-range missile development reflected ambitions extending beyond South Asia. Adviser to National Command Authority, Lt Gen (ret’d) Mazhar Jamil, made the comments while addressing a seminar on Pakistan’s nuclear weapon program organised by the Centre for International Strategic Studies (CISS). “The trajectory of India’s strategic forces program, including its intercontinental range missile systems, is not oriented solely toward Pakistan or China. It is oriented toward establishing India as a global nuclear power capable of threat-

ening major Western capitals,” Gen Jamil, a former director general of the Strategic Plans Division, claimed. He asked Western Governments to take notice of India’s military modernisation. Jamil also said that Pakistan’s restraint during the May conflict with India was “a deliberate and considered choice.” He warned that any future military action would draw a “decisive and comprehensive” response. In his opening remarks, CISS Executive Director Ali Sarwar Naqvi said Pakistan’s nuclear capability had helped maintain “deterrence stability” in South Asia and “prevented a large-scale war”.

Crew evacuated after third vessel with Indians attacked off Oman

Crew members of a tanker carrying 20 Indians were evacuated on Thursday after the vessel came under attack off an Oman port, Indian officials said. This was the third instance of a merchant ship with Indian crew members coming under attack from the US military off the Oman coast in the last four days. A Palau-flagged oil tanker carrying 24 Indian seafarers was disabled by US forces on Monday. All crew members of the vessel, MT Marivex, were safely rescued. On Wednesday, the US struck another Palau-flagged tanker, MT Settebello, killing three out of the 24 Indian sailors on board.



Following Wednesday’s incident, the Ministry of External Affairs (MEA) summoned US Charge d’Affaires Jason Meeks and he was handed a diplomatic note of protest. The third attack — on a Guinea-Bissau-flagged vessel identified as MT

jalveer — took place on Thursday. The Indian Embassy in Muscat said in a post on X: “The rescue operation with the support of the Omani authorities has been successfully completed and all the 20 Indian crew members have been evacuated ashore. The Mission is coordinating with the Omani authorities on further actions.” The mission had earlier posted that 22 Indian crew members were evacuated, and later revised the figure to 20. The MEA confirmed that the ship had come under attack. “These attacks came from the US Navy that is stationed there,” MEA spokesperson Randhir Jaiswal said at a press briefing in New Delhi while responding to a question on the incidents involving the vessels. “We attach high importance to the welfare and well-being of our seafaring community,” Jaiswal said. He further said India has conveyed that “dialogue and diplomacy is the way forward for the peaceful resolution of the conflict”.
