Notice of sale under Rule 9(1) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mr.S. Surya Kumar and Mrs.S. Rekha availed loan facility from Indian Bank, Alwarpet Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.S. Surya Kumar and Mrs.S. Rekha failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.07.2018 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling Mr.S. Surya Kumar and Mrs.S. Rekha liable to the Bank to pay the amount due to the tune of **Rs.35,83,330/- (Rupees Thirty Five Lakhs Eighty Three Thousand Three Hundred And Thirty only)** as on 17.07.2018 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 18.07.2018.

As Mr.S. Surya Kumar and Mrs.S. Rekha failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 07.11.2018 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 05.06.2026 is **Rs.84,48,393/- (Rupees Eighty four lakhs forty eight thousand three hundred and ninety three only)** with further interest, costs, other charges and expenses thereon from 06.06.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.06.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.
