As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement )Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due **Rs. 6113143.50 (Rupees Sixty one Lacs Thirteen Thousand One Hundred Forty Three and Paise Fifty only)** as on **07.08.2025**, with further interest, charges & expenses thereon due to the Indian Bank.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15 days**.

**The date of sale is fixed as 24.06.2026 which would be by e-auction mode.**

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **08.06.2026 to 23.06.2026 between 10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
