

To hike LS strength, Govt works on more clarity, eyes South, DMK support

TWO MONTHS after its first attempt to pass a Constitution amendment to operationalise delimitation and women's reservation was defeated in the Lok Sabha in April, the government now plans to reintroduce it with some changes that clarify that the number of seats of all states in the Lok Sabha with an enhanced strength of 850 seats will be in proportion to their existing numbers.

According to at least two senior government functionaries, talks are ongoing with the DMK, which recently lost the Assembly elections in Tamil Nadu. With Lok Sabha MPs of Trinamool also resigning, issue-based support may be forthcoming from both the DMK and the Trinamool Congress, they said. Both had earlier rejected the Constitution amendment Bill.

The government plans to retain the 1971 Census in which the increased number of seats will be allocated among states while increasing the maximum strength of the Lok Sabha from 550 to 850, a senior government functionary and BJP leader told The Indian Express. A Delimitation Commission, to be set up following the enactment of a separate Delimitation Bill, will decide on how the new Lok Sabha and Assembly constituencies will be redrawn.

For the division of Assembly constituencies within states, the 2011 Census could be the basis, changing from the current basis of 2001 Census, one of the two functionaries said. As of now, Article 81 (3) of the Constitution says the allotment of Lok Sabha seats to states and the division of states into territorial constituencies would be as per population "at the last preceding Census", until the figures for the first Census taken after 2026 are published. Delimitation and Census

A big concern around delimitation is the year of Census to be used for deciding how Lok Sabha seats will be allocated among states. The Bill is likely to clarify that seats will be proportionate to states' population as in Census 1971.

ior government functionary argued that if the Constitution amendment is not passed, the delimitation process would get automatically triggered when the ongoing 2027 Census, which has a reference date of March 1, 2027, is completed next year. This would mean that the gap between the Northern states and Southern states in terms of population, and therefore the distribution of seats, would widen.

"This is one good reason for southern states to agree to what is being proposed," the functionary said, referring to Union Home Minister's earlier statement in Lok Sabha that each state's number of Lok Sabha seats would go up by 50% when the Lok Sabha strength goes up from 543 now to 816.

But there is a lot at stake for southern states now, argued the senior BJP leader and government functionary. If the size of the Lok Sabha is not increased, then the southern states would see a reduction in seats, which would be more if the basis is 2027 instead of 2011. In case the Opposition does not agree, the freeze on readjustment of seats that has been there for the past 50 years would expire as soon as the 2027 Census is notified next year, automatically triggering delimitation on the basis of this Census, BJP sources said.

8 killed as molten metal spills, triggers fire at Vizag steel plant

AT LEAST eight workers were killed on Monday when a ladle carrying molten steel broke and caused a massive fire at the Rashtriya Ispat Nigam Ltd (RINL) plant, also known as Visakhapatnam Steel Plant, officials said.

At least six workers were injured in the incident and taken to nearby hospitals. Multiple fire trucks and dozens of firefighters were pressed to bring the fire under control. Visakhapatnam District Collector M Abhishikth

Kishore confirmed that eight people died. "The mishap occurred at 4.15 pm. The injured have been admitted to two private hospitals where they are stable," he said.

Officials said the temperature of the molten steel in the large industrial ladle was around 1,500-1,600 degrees Celsius.

The Union Ministry of Steel said a sudden explosion had triggered the accident. "At the time of the incident, casting operations were underway at Caster-2 of Steel Melt Shop-1. Before the slide gate could be opened to pour hot crude steel from the ladle to the tundish for further

casting, a sudden and severe explosion took place. A large ball of fire rose to the ceiling of the shop, and Overhead Crane-2 subsequently caught fire," the ministry said in a statement, adding that it was closely monitoring the situation and extending all necessary support to the affected families and injured workers.

Visakhapatnam Police Commissioner Dr Shankbratha Bagchi told The Indian Express on Monday evening that rescue operations were underway. "We are still on the job. It will take hours," he said.

Police identified the de-

ceased as G V Apparao, Prabharak, Bheem Kumar, Krishna Nag, Gold Kumar, Trinadh, Appala Raju, and Ramana. Five of them were employees of the plant, and three were contract labourers, officials said.

RINL has initiated an investigation to ascertain the cause of the incident, the Steel Ministry said. A three-member external enquiry committee, headed by the Director-in-Charge, Bokaro Steel Plant, Steel Authority of India Limited (SAIL), has also been constituted to conduct an independent inquiry.

Andhra Pradesh Chief Minister N Chandrababu Naidu ex-

pressed shock and grief at the incident. The CM spoke with the District Collector and Police Commissioner, and directed them to provide help for the families of affected persons. Officials briefed the CM on the ongoing situation and relief operations.

Prime Minister Narendra Modi expressed his sadness at the loss of lives and announced Rs 2 lakh ex gratia to the families of the deceased and Rs 50,000 to the injured. "Saddened by the mishap at the Visakhapatnam Steel Plant. Condolences to those who have lost their loved ones. Praying that the injured re-

cover at the earliest. The local authorities are providing all possible assistance to those affected. An ex gratia of Rs 2 lakh from PMNRF would be given to the next of kin of each deceased. The injured will be given Rs 50,000," the Prime Minister's Office quoted the PM as saying.

Former chief minister and YSRCP president Y S Jagan Mohan Reddy also expressed grief over the incident. Demanding a comprehensive inquiry, Jagan called for strict action against those found responsible and stressed that worker safety must remain the highest priority in all industrial establishments.

Report: India likely to have expanded nuclear stockpile to 190 in 2025

INDIA is believed to have slightly expanded its nuclear stockpile in 2025 and continued developing new types of nuclear delivery systems, while Pakistan's focus has been on new delivery systems and accumulation of fissile material in 2025, according to a new report released by the Stockholm International Peace Research Institute (SIPRI) on Monday.

According to the report, at the start of 2026, nine countries — the United States, Russia, the United Kingdom, France, China, India, Pakistan, North Korea and Israel — together possessed approximately 12,187 nuclear weapons, of which 9,745 were in military stockpiles and considered potentially operationally available. "Nearly all of these warheads belonged to Russia or the USA, and to a lesser extent France and the UK, but China and India may now occasionally deploy a small number of warheads mounted on missiles during peacetime," it said.

The report further stated that India has deployed 12 nuclear warheads at present, and the country's total nuclear stockpile is estimated at around 190 warheads as of January 2026, up from 180 a year ago. "It has long been assumed that India stores its nuclear warheads separately from its deployed launchers during peacetime. However, the country's recent moves towards placing missiles in canisters and conducting sea-based deterrence patrols suggest that India could be shifting in the direction of mating some of its warheads with their launchers in peacetime," it said.

"Based on this assessment, SIPRI estimates that, as of January 2026, India may have started to deploy a small number of nuclear warheads on a single SSBN conducting occasional deterrence patrols," the report noted. About Pakistan, the report said its nuclear warhead stockpile is thought to have remained stable at around 170 warheads as of January 2026, although it continued to develop its nascent nuclear triad during 2025.
