

Rs 16.5L compensation given to families of 11 Bhatkal victims

THE families of the 11 people who drowned while collecting bivalves in the Padushirali estuary in Bhatkal taluk last week have received compensation of ₹16.5 lakh each.

The state government had earlier announced an ex gratia payment of ₹5 lakh for the family of each deceased. Former minister Mankal Vaidya met the bereaved families and distributed the compensation cheques.

The total compensation package comprises ₹55 lakh from the state government (₹5 lakh per family), ₹1.10

crore from the Department of Fisheries (₹10 lakh per family), ₹50,000 each from the Janatha Co-operative Society, Bhatkal, and ₹1 lakh each as a personal contribution from Mankal Vaidya. In total, each family received ₹16.5 lakh.

Vaidya also announced that he would take responsibility for the education of all children from the affected families. He said efforts are being made to employ one member from each family in the co-operative banks in the district.

Clarifying the sequence of events that led to the tragedy, Vaidya said the victims had been collecting bivalves in the estuary for nearly a

decade.

"There has been a tradition of collecting bivalves in the estuary. The victims found a large number of bivalves on and beneath the rocks. Two persons entered deep water and began drowning. In an attempt to rescue them, the others also drowned," he said.

Questions had been raised about how experienced collectors could drown, given that collecting and selling bivalves was their regular source of livelihood.

The minister appealed to organisations and philanthropists to extend support to the bereaved families and assured them that housing would also be provided.

FIR against 12 in Vijayapura murder

AN FIR has been registered against 12 persons in connection with the brutal murder of six people in Chadchan taluk of Vijayapura district on Friday. Police said no arrests have been made so far as the investigation is underway.

The case was registered based on a complaint filed by a member of the Nirale family, five of whose members, along with a worker, were hacked to death.

Most of those named in the FIR belong to the family of Kallanagouda Patil, an influential figure in Chadchan taluk. Kallanagouda has been named as accused No. 1.

The six victims were allegedly hacked to death in broad daylight in Govindapura village following a dispute over property.

Meanwhile, the last rites of all six victims were performed under tight police security in Govindapura village on Saturday. Five of the deceased were cremated, while one victim, who was a Muslim, was buried.

Police officials said the investigation is progressing and expressed confidence that the accused would be arrested soon.
