

Cong eyes reset as Revanth govt enters 2nd half of term

Exercise may go beyond Cabinet expansion; PCC chief may be changed

HAVING completed half of its five-year tenure, the Revanth Reddy government appears headed for its biggest shake-up since coming to power in December 2023.

With the Congress high command said to be weighing changes in both the Cabinet and the party organisation, ministers, MLAs and aspirants have begun jockeying for position, turning Hyderabad and New Delhi into hubs of intense political activity.

According to sources in the ruling party, the proposed exercise is expected to go beyond a routine Cabinet expansion.

The Congress leadership is reportedly considering a broader overhaul that could involve dropping some ministers, inducting fresh faces, redistributing key portfolios and reorganising the Telangana Pradesh Congress Com-

mittee (TPCC). Party insiders say two or three ministers could be shown the door as part of the exercise. However, the move is not being viewed as a demotion. Those

relieved of Cabinet responsibilities may instead be assigned organisational roles in the All India Congress Committee (AICC), with some potentially being made in-charge of states such as Gujarat,

Goa and Uttar Pradesh, which are scheduled to go to the polls next year.

The possibility of changes in the state party unit is also generating considerable discussion. One of the names being widely talked about is TPCC president and MLC B Mahesh Kumar Goud, who is said to be under consideration for a Cabinet berth. His induction would also address the absence of Cabinet representation from Nizamabad district.

If Mahesh moves into the Cabinet, party leaders believe a change at the helm of the TPCC could follow. Minister Ponnamp Prabhakar's name is doing the rounds as a possible successor.

A long-time Congress leader who rose through the NSUI ranks and later represented Karimnagar in Parliament, Prabhakar is seen as someone with strong organisational credentials.

Govt revokes suspension of IAS officers

After falling out of favour with the previous LDF government, IAS officers N Prasanth and B Ashok are set to return to service under the UDF regime. Chief Minister VD Satheesan revoked the suspension orders against both officers on Saturday, with their fresh postings expected soon.

Both officers had been highly critical of the previous Pinarayi Vijayan government. While 2007 batch IAS officer Prasanth had been under suspension for two years, his senior Ashok, of the 1998 batch, underwent the disciplinary action for one-and-a-half months. Prasanth was suspended on November 11, 2024, for criticising chief secretary A Jayathilak on social media.

The suspension has since been extended multiple times. Ashok was suspended in April this year following an interview in which he allegedly criticised Pinarayi and the LDF government's functioning.

Reddy withdraws resignation, no portfolio change now

HUMBLLED by the Congress high command, senior party MLA Ramalinga Reddy on Saturday evening withdrew his resignation from the DK Shivakumar cabinet.

Reddy, who represents BTM Layout in the Assembly, had resigned after he was miffed at not getting the Bengaluru development port-

folio and instead was allotted the Major and Minor Irrigation ministry. Reddy had further claimed that Shivakumar had promised him the Bengaluru Development portfolio way back in 2023. Reddy, however, will not get the Bengaluru Development portfolio, and instead Byatarayanapura MLA Krishna

Byre Gowda will continue with that portfolio.

Reddy can choose from the portfolios remaining with the CM and those that will be distributed during the cabinet expansion. The total strength of the cabinet, including the CM, is 34. Twenty berths are still vacant.

According to informed sources, Reddy, an eight-time MLA, may opt for the higher education portfolio and additionally get a minor portfolio such as endowments. It is not clear as yet whether the change in portfolio will happen soon or during the cabinet expansion, which is likely after the June 18 elections to four Rajya Sabha and seven MLC seats from Karnataka.
