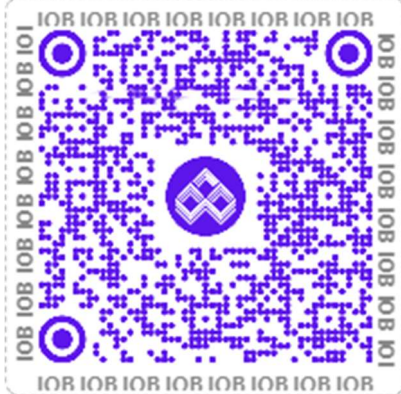

Further, they are requested to upload requisite KYC documents. Once the KYC documents are uploaded and verified by service provider, the intending Bidders/Purchasers has to transfer the EMD amount in his Wallet well before the e-Auction end Date and time in the portal.
