Assam Skater Navhyam Nihan Borah Wins Silver at International Speed Skating Championship 2026 in Jakarta

Assam Rising, Guwahati, June 2: Assam's young skating talent Navhyam Nihan Borah has made a mark on the international stage by winning a silver medal at the International Speed Skating Championship 2026 held in Jakarta from May 29 to 31.

Representing India, the young athlete competed against participants from Singapore, Malaysia, Myanmar and Indone-

sia, showcasing strong performance across multiple categories. He secured the silver medal in the 400-metre Speed Race in the Basic Inline Skating Boys Category C, displaying notable speed, technique and determination.

In addition to his podium finish, Borah delivered commendable performances in other events as well. He narrowly missed qualification for the final round of the 300-metre

race and progressed to the semi-finals in the 500-metre category, reflecting consistent form throughout the competition.

He also took part in the 1,800-metre International Team Relay event alongside two other Indian skaters. Although the team completed the race successfully, they narrowly missed out on a medal based on final timings.

The achievement adds to his growing sporting pro-

file. Earlier this year, he emerged as the champion at the 25th National Speed Skating Championship held in Chennai, further strengthening his reputation as one of India's promising young skating athletes.

His performance in Jakarta has been widely regarded as a significant milestone, bringing pride to Assam and serving as an inspiration for emerging athletes in the region.

Assam: Heroin Worth Rs 1 Crore Seized in Jorhat Anti-Drug Operation, Two Arrested

Assam Rising, Jorhat, June 2: In a significant breakthrough against drug trafficking, Assam Police seized heroin worth nearly Rs 1 crore from TRP Road in Jorhat and arrested two youths allegedly involved in the illegal narcotics trade.

According to police officials, the accused were intercepted while travelling on a motorcycle during a special operation carried out based on intelligence inputs. A subsequent search led to the recovery of a substantial quantity of heroin, estimated to be worth around Rs 1 crore in the illegal market.

Preliminary findings suggest that the two arrested individuals were transporting the contraband from Merapani to

Jorhat when they were apprehended by the police team. A case has been registered in connection with the seizure, and further investigation is underway to trace the origin of the narcotics as well as identify other individuals linked to the trafficking network.

Authorities said the operation marks a notable success in the ongoing crackdown against drug smuggling and illegal narcotics activities in Assam, where enforcement agencies have intensified action against trafficking routes in recent months.

Assam to Launch Massive Plantation Drive on World Environment Day, Targeting 1 Crore Saplings



Assam Rising, Guwahati, June 2: The Assam government has planned a large-scale plantation drive across the state on June 5, aiming to plant 1 crore saplings with the participation of more than 35 lakh women members of Self-Help Groups (SHGs) on the occasion of World Environment Day. Assam Panchayat and Rural Development Minister Atul Bora said the initiative reflects the state government's commitment to maintaining ecological balance and promoting environmental sustainability through mass participation. He stated that under the leadership of Chief Minister Himanta Biswa Sarma, the government has consistently prioritised environmental protection through afforestation programmes, forest restoration efforts, promotion of clean energy and the use of modern technology in conservation initiatives. Ahead of the campaign, Bora chaired a review meeting in Guwahati with senior officials of the Panchayat and Rural Development Department to assess preparedness and implementation strategies. A senior official from the Environment and Forest Department was also present during the meeting.

The minister directed officials to make all necessary arrangements to ensure the smooth execution of the

programme, emphasising active public participation and effective monitoring mechanisms to achieve the target. Officials also reviewed ongoing departmental initiatives, including the Lakshmi Baideo Programme, during the meeting. Senior bureaucrats present included Additional Chief Secretary B. Kalyan Chakravarty, Commissioner Keerthi Jalli, ASRLM Mission Director Kuntalmoni Sama Bordoloi, SPMS officials Anindita Deka and Nabajit Bhargali, and Additional Principal Chief Conservator of Forests Hirdesh Mishra, among others.
