

Now, free bus ride for women in Kerala

Chief Minister Satheesan says initiative marks the start of journey toward self-respect of women

THE UDF government officially rolled out its flagship ‘Priyadarshini’ free travel scheme for women and transgender persons on Monday, fulfilling a key election promise within a month of taking office.

Inaugurating the scheme at Thiruvananthapuram Central KSRTC Complex, Chief Minister VD Satheesan expressed “immense joy” for having fulfilled a promise he made to the people.

“I am starting this bus journey with the immense joy of having fulfilled the promise made to the people during the election time,” Satheesan said.

“This is no ordinary bus ride; it marks the start of a journey that upholds the self-respect of women in Kerala and guides them to-

wards self-reliance and financial security.” He emphasised that the project was a calculated socio-economic driver rather than a mere favour. Women and transgender persons irrespective of age or income can avail unlimited free rides on KSRTC ordinary services under ‘Priyadarshini’, the first instalment of the government’s five ‘Indira Guarantees’.

“The transformation brought about by the Priyadarshini scheme will reflect in every household, especially in the lives of tens of thousands of women who have to travel several kilometers daily for their work,” he said.

“Let the money they spend on tickets turn into small savings for them. It will boost their self-confidence and mental strength.” Though the project carries an annual financial burden of ₹800

crore, Satheesan, who also holds the finance portfolio ahead of Friday’s state budget, assured the public that it would not push KSRTC into financial distress.

On extending the same scheme to men, the CM said when a woman asked what to do with her savings, he advised her to join a chit

fund. Extending this to men won’t increase household savings the same way, he joked.

On the apprehensions raised by private bus operators, the CM promised to back them if the scheme impacts them. “They are part of the public transport system, too. I understand that they are in a crisis. They have my word that we will create a supportive ecosystem for them,” he said.

On the occasion, Transport Minister C P John spoke about incorporating local bodies’ support to improve public transport and expanding KSRTC’s fleet through corporate sponsorships.

Following the inaugural ceremony, CM V D Satheesan and his cabinet colleagues rode a KSRTC bus driven by V P Sheela, Kerala’s first woman driver recruited through the PSC.



TG govt ready to bankroll Metro Phase 2, says Revanth

TELANGANA Chief Minister A Revanth Reddy on Monday said the State government was prepared to execute Hyderabad Metro Rail Phase-2 with 100% equity and urged the Centre to immediately issue a no objection certificate (NOC) for the project.

Addressing reporters at the Secretariat, Revanth alleged that Union Minister G Kishan Reddy was delaying an Indian Railway Finance Corporation (IRFC) loan for the State’s takeover of Hyderabad Metro Phase-1 and creating hurdles to the approval of Phase-2.

He also accused Kishan of acting at the behest of K Chandrasekhar Rao and KT Rama Rao, alleging “collusion politics” between the BRS and BJP over the Metro project. “KTR and KCR conspired and Kishan Reddy is executing,” Revanth alleged.

“We respect Kishan Reddy, but we are frustrated with him now,” he added, questioning why the Union minister had surrendered to KCR.

Recalling that an MoU had been signed between IRFC, HMRL and L&T for refinancing ₹13,600 crore linked to the takeover of Metro Phase-1, Revanth said the amount, due for disbursal.

PM to launch major infra projs in Odisha

PRIME Minister Narendra Modi is set to make a one-day visit to Odisha on June 20 to participate in a state-level celebration marking the completion of two years of the BJP government led by Chief Minister Mohan Charan Majhi.

BJP general secretary Biranchi Narayan Tripathy on Monday told mediapersons that the prime minister will first arrive at Pahadpur in Mayurbhanj at around 11.15 am, and head to Gosani Peetha, a prominent local shrine, to offer his prayers.

Thereafter, he will visit the in-laws’ place of President Droupadi Murmu, where he is likely to spend over an hour interacting with her family members and vil-

lagers. Modi will then proceed to Dandbose, a place near Rairangpur and the venue for the public meeting which is scheduled to start at 12.55 pm.

The President will also join the second anniversary programme of the government. During the event, Modi will address a massive public gathering and launch a slew of infrastructure projects at the event.

Modi visit assumes significance as it comes amid the state government’s second anniversary celebrations and the Centre’s renewed focus on the infrastructure and economic development of the State.

Tripathy said Modi will inaugurate and lay foundation stones for projects worth several thousand crores of rupees. He said the state government is currently finalising a list of key projects.
