Mr. MANOJ KAMBRATH AND Mrs. NISY MANOJ KAMBRATH have availed loan facility from Indian Bank Kannur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. MANOJ KAMBRATH AND Mrs. NISY MANOJ KAMBRATH failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 10-01-2025(published on 05.03.2025) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr. MANOJ KAMBRATH AND Mrs. NISY MANOJ KAMBRATH liable to the Bank to pay the amount due to the tune of Rs.38,86,427 (Thirty Eight Lakh Eighty Six Thousand Four Hundred and Twenty Seven Only) as on 09-01-2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 10-01-2025.

As Mr. MANOJ KAMBRATH AND Mrs. NISY MANOJ KAMBRATH failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 21-06-2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 16.06.2026 is Rs.45,79,864/- (Rupees Forty five lakhs seventy nine thousand eight hundred sixty four Only) with further interest, costs, other charges and expenses thereon from 17.06.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.07.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from 25.06.2026 to 24.07.2026 between 10.00 am to 4.00 pm at Indian Bank, Kannur Branch, Abhilash Tourist Home Building, Railway Station Road, Kannur - 670001.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
