E-Auction Sale Notice

Whereas 1.M/s.Nabi Agencies Rep by its Prop Nabi Rasool 2. Mr Nabi Rasool S/o Syed Hussain 3.S Fakrumabi W/o Sayyed Hussain have borrowed monies from Indian Overseas Bank, **Anantapur** Branch against the mortgage of the immovable properties more fully described in the schedule hereunder and upon classification of the account as NPA, the Bank has issued a **Demand Notice** to the Borrowers/mortgagers under Section 13(2) of the SARFAESI Act, 2002 (Act) on **12.01.2026** calling upon the borrowers **1.M/s.Nabi Agencies Rep by its Prop Nabi Rasool 2. Mr Nabi Rasool S/o Syed Hussain 3. S Fakrumabi W/o Sayyed Hussain (C-Obligant/Mortgager)** to pay the amount due to the Bank, being **Rs.9,37,163.50 (Rupees Nine Lakhs Thirty Seven Thousand and One Hundred Sixty Three and paisa Fifty only) as on 11.01.2026** payable together with further interest, at contractual rates and rests along with costs and charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrower/ Mortgagor having failed to pay the amount dues in full to the bank as called for in the said demand notice, the bank has taken **possession** of the secured assets more fully described in the schedule hereunder on **21.04.2026** under Section 13(4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under section 13(4) of the Act read with the rules 8&9 of the Security Interest (Enforcement) rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.9,37,163.50/- as on 21.04.2026 with further interest & costs**, payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **11.06.2026** is **Rs.10,23,874.56 (Rupees Ten Lakhs Twenty Three Thousand Eight Hundred Seventy Four and Paise Fifty Six Only)** after reckoning repayments if any subsequent to the bank issuing the demand notice.

Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **20.07.2026 before 1.00 p.m.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (**After generation of Challan from <https://www.baanknet.com> which will provide account details**) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.
