

India sends LOR buy 114 Rafale jets

NEW DELHI: The defence ministry has sent a letter of request (LOR) to the French government for buying 114 Rafale fighter jets to sharpen the Indian Air Force's combat edge and hopes to conclude a contract in the financial year 2026-27, officials aware of the matter said on Monday.

Negotiations for the government-to-government deal are expected to begin after the French side responds to the Indian request, the officials said, asking not to be named. The LOR, sent out last week, outlines the air force's requirements and the proposed procurement terms. This development comes as Prime Minister Narendra Modi is travelling to France in mid-June for the outreach session of the G7 Summit.

The Rafale capability boost is expected to cost around ₹3.25 lakh crore. The next steps before

an actual deal include technical discussions, cost negotiations and final approval from the Cabinet Committee on Security.

In February, the Defence Acquisition Council (DAC)—India's apex military procurement body—cleared the purchase of military hardware worth ₹3.6 lakh crore, including 114 Rafale jets, under the MRFA (multi-role fighter aircraft) programme. The council's acceptance of the necessity for new fighters was the first step in the procurement process.

Under the MRFA model being

considered, the Rafales will be manufactured in India by the French aircraft manufacturer Dassault Aviation and a local partner. IAF chief Air Chief Marshal AP Singh reached France on Monday for a four-day visit aimed at boosting defence cooperation. On Tuesday, he will visit Dassault Aviation's Merignac facility which houses the Rafale's final assembly line. France is expected to supply 20 Rafale jets in fly-away condition, while the remaining will be manufactured in India. India has held talks with France regarding the localisation of the Rafales to be manufactured in India, the integration of local weapons and other India-specific requirements.

The IAF already operates 36 Rafale fighter jets bought from France for ₹59,000 crore. Also, India ordered 26 Rafale Marine fighter jets from France in April 2025 for the navy, which will operate them from its two aircraft carriers.

NEW DELHI: As India is engaged with the US and the UK separately giving final touches to the trade deals this week, officials said large part of the agreement with the US is already finalised and British trade secretary Peter Kyle is in Delhi to bring the India-UK free trade agreement into force.

Union commerce minister Piyush Goyal on Monday said India and the US have finalised most elements of the proposed interim bilateral trade agreement (BTA), and the two sides will focus their discussions on remaining few issues from June

2-4 in New Delhi. Goyal's comments came days after US ambassador Sergio Gora said that India-US trade deal was 99% done. HT reported it on Saturday. Meanwhile, a British government statement on Monday highlighted an expected meeting between Kyle and Goyal in New Delhi on Tuesday "to discuss bringing the FTA into force as quickly as possible", calling it "a priority" for both governments.

People in the know, requesting anonymity, however, said that there are no specific deadlines for these deals as finalisation of agreements and their operationalisation depends on various factors. India has been engaged with both the UK

and the US to finalise the trade deals that are "mutually" beneficial.

A US embassy spokesperson confirmed that a US delegation led by Assistant US Trade Representative Brendan Lynch is visiting India from June 1-4 to continue discussions toward finalising a US-India trade agreement.

According to the UK government statement, as global conflicts, including the continued blockade of the Strait of Hormuz, are causing economic shocks across the world's biggest economies, Kyle sees advancing the UK's vital economic partnership with India as a key priority, with significant mutual benefits.

India-Oman free trade pact takes effect: Union minister

NEW DELHI: The India-Oman free trade agreement (FTA) became operational on Monday, giving Indian exporters duty-free access to 99.38% of shipments to the Gulf gateway and East African markets, Union commerce minister Piyush Goyal said.

"The India-Oman CEPA [Comprehensive Economic Partnership Agreement] marks a defining milestone in India's engagement with

Oman and reflects Hon'ble Prime Minister Shri Narendra Modi's vision of forging trade partnerships that deliver gains for farmers, fishermen, youth, women, entrepreneurs and micro, small and medium enterprises," he said.

CEPA was signed on December 18 last year in the presence of PM Modi and Sultan Haitham bin Tarik Al Said, in Muscat.
