Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders / Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet by **29.06.2026 up to 03.00 pm in the portal**. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.
