



Govt clears appointment of three additional judges of Karnataka HC

Bengaluru, June 1 : Union Minister of State (Independent Charge) for Law and Justice and Parliamentary Affairs, Arjun Ram Meghwal, has announced the appointment of three judicial officers as Additional Judges of the Karnataka High Court. In a post on social media platform X, the Union Minister said that the appointments were made by the President Droupadi Murmu in exercise of the powers conferred by the Constitution of India.

DMK extends deadline for poll debacle review report to June 10

Chennai, June 1 : The Dravida Munnetra Kazhagam (DMK) has extended the deadline for its poll debacle review committee to submit its report, giving the panel five additional days to complete its assessment of the party's disappointing performance in the recent Assembly elections. In a statement issued by the DMK headquarters, the party said that the review committee had sought additional time to gather feedback from party workers, candidates and functionaries across the state before finalising its findings. Accepting the request, the party leadership extended the deadline for submission of the report from June 5 to June 10. The review committee was constituted by DMK President M.K. Stalin soon after the party's unexpected electoral setback. The 38-member panel was tasked with conducting a comprehensive examination of the factors that contributed to the party's defeat and recommending measures to strengthen the organisation ahead of future political

battles. Party sources said the committee has been travelling extensively across Tamil Nadu, holding consultations with district-level leaders, constituency functionaries, grassroots workers and candidates who contested the elections. The exercise is aimed at obtaining first-hand assessments of local issues, campaign



shortcomings, organisational weaknesses and voter perceptions that may have influenced the electoral outcome. As part of its outreach initiative, the DMK has also launched a dedicated online portal to collect suggestions and opinions from party cadres as well as members of the public regarding the reasons behind the poll setback. The portal has generated a significant response, reflecting widespread interest within the party ranks in the introspection process.

SC denies bail to former Jharkhand Minister Alamgir Alam, orders speedy trial

New Delhi, June 1 : The Supreme Court on Monday rejected the bail pleas of Jharkhand's former Rural Development Minister Alamgir Alam and his private secretary Sanjeev Lal in a money laundering case linked to an alleged tender commission scam. The court, however, directed that the trial be expedited. A bench of Justice M.M. Sundresh and Justice N. Kotiswar Singh declined relief to both accused, who have been in judicial custody for over 18 months, and instructed the trial court to record statements of key witnesses within four weeks.

Assam Guv leads delegation with Buddha relics to Mongolia

Guwahati, June 1 : Assam Governor Lakshman Prasad Acharya has been leading an Indian delegation carrying the Holy Relics of Lord Buddha's two principal disciples, Arhant Sariputra and Arhant Maudgalyayana, to Mongolia for a sacred exposition aimed at strengthening the centuries-old spiritual and cultural ties between the two countries, officials said on Friday. The exposition is being organised un-

der the aegis of the Ministry of Culture, Government of India, and is being regarded as a landmark spiritual and diplomatic initiative reflecting the shared Buddhist heritage of India and Mongolia. The sacred relics, preserved at the Sanchi Vihar Chaitya in Madhya Pradesh, will be taken to Mongolia with full ceremonial honours and will remain there till June 9, 2026. The relics originate from the historic Sanchi Stupa, a UNESCO World Heritage Site and one of the most revered centres of Buddhist heritage. According to an official statement issued by the Raj Bhavan on Thursday, the initiative has been undertaken at the special instance of Prime Minister Narendra Modi as part of India's continued efforts to deepen its enduring spiritual and civilisational connec-



tions with Mongolia, often described as India's "spiritual neighbour" in the Buddhist world. Governor Acharya is scheduled to depart for Mongolia on May 30, leading the Indian delegation entrusted with the sacred relics.

PM SHRI initiative set to strengthen education system in Jharkhand's Palamu

Palamu, June 1 : A major step has been taken under the Pradhan Mantri Schools for Rising India (PM SHRI) scheme to improve the condition of schools at the district level and enhance their overall appearance. In Jharkhand's Palamu district, an amount of Rs 3,96,75,000 has been allocated to 27 selected schools for the financial year 2025-26 to provide basic facilities and create a child-friendly learning environment. Assistant District Prosecution Officer Ambujaya Pandey said that there are 28 PM SHRI schools in Palamu, but work is currently underway in 27 schools. He added that funds will be released in two phases.



So far, a budget of more than Rs 3 crore has already been provided. Several activities are planned under the scheme, and with the support of the district administration, efforts are being made to effectively implement them. He also said that special focus is being given to the beautification of schools. Steps are being taken to develop gardens, carry out proper repairs.
