

Chief Minister Chandrababu Naidu Meets Singapore Foreign Minister Vivian Balakrishnan

Visakhapatnam (TSIT): Andhra Pradesh Chief Minister N. Chandrababu Naidu met Singapore Minister for Foreign Affairs Vivian Balakrishnan and held extensive discussions on strategic partnership opportunities between Andhra Pradesh and Singapore. During the nearly 30-minute meeting, several key issues, including state development, investments, air connectivity, green energy and the establishment of data centres, were discussed.

On the occasion, Chief Minister Chandrababu Naidu briefed the Singapore Foreign Minister on the development plans for the Amaravati Capital City Project. He stated that the Government was taking special measures to transform Amaravati into a "Quantum Valley." The Chief Minister noted that Andhra Pradesh was emerging as one of the leading states in the country in both the manufacturing and services sectors. He further explained that the State possesses vast land resources required for industrial development, while also having an abundant pool of skilled human resources to support the growth of the services sector. Chandrababu Naidu highlighted Andhra Pradesh's growing role in the production of green energy, green



ammonia and green hydrogen. The Chief Minister pointed out that the State's extensive coastline and strategically located ports offer significant advantages for cargo transportation and international trade.

He informed the Singapore Foreign Minister that the data centre ecosystem was expanding rapidly in regions such as Visakhapatnam, with undersea cable connectivity linking data services with countries across the globe. Chandrababu Naidu also informed Vivian Balakrishnan about the

proposed establishment of a major steel plant by global steel giant ArcelorMittal in North Andhra Pradesh. The two leaders further discussed the expansion of air services between Andhra Pradesh and Singapore, including the possibility of providing direct flight connectivity to various airports in the State.

State Minister P. Narayana, Shilpak Ambule, High Commissioner of India to Singapore, and other senior officials participated in the meeting. Following the discussions, Singapore Foreign Minister

Vivian Balakrishnan presented Chief Minister Chandrababu Naidu with a copy of the book titled "Fifty Secrets of Singapore's Success," which highlights the factors behind Singapore's remarkable development journey. Officials expressed the view that the meeting would further strengthen bilateral relations between Andhra Pradesh and Singapore and provide fresh momentum for future investment opportunities and development partnerships between the two sides.

Unprecedented Progress in Women, Child and Tribal Welfare Sectors in the Last Two Years: Minister Gummidi Sandhya Rani

The South India Times, Visakhapatnam : State Minister for Women Development, Child Welfare and Tribal Welfare Gummidi Sandhya Rani stated that under the leadership of Chief Minister N. Chandrababu Naidu and with the support of Deputy Chief Minister Pawan Kalyan, the State Government has accorded the highest priority to the welfare of women, children and tribal communities, implementing welfare and developmental programmes on an unprecedented scale over the past two years. The Minister said that welfare is not merely about providing financial assistance, but ensuring safety for every woman, nutritional support for every child, development opportunities for every tribal family and quality education for every student.

She stated that through 56,746 Anganwadi Centres across the State, nutritional support, healthcare services and pre-primary education are being provided to pregnant women, lactating mothers and children. Nearly 20 lakh beneficiaries are availing these services. Strengthening the Anganwadi system, the Government has recruited 5,389 teachers and 5,287



helpers, creating employment opportunities for more than 11,000 people, she said. To improve infrastructure in Anganwadi centres, facilities such as drinking water supply, RO plants, sanitation amenities and cooking equipment have been provided with an expenditure of Rs.100 crore, the Minister explained. She further stated that the services offered through Anganwadi centres have been digitised by distributing 5G smartphones to Anganwadi staff at a cost of Rs.72 crore. Emphasising the Government's commit-

ment to women's safety, the Minister said that One Stop Centres have been established in all 26 districts of the State, providing legal,

medical, psychological and police assistance under one roof. She revealed that 3,393 child marriages had been prevented during the last two years. In the tribal welfare sector, the Minister stated that quality education is being imparted to thousands of students through 2,715 educational institutions across the State. Necessary infrastructure, nutritious food and stationery are being provided to students residing in hostels and Ashram schools.

Foundation Stone to be Laid for Rs.142-Crore Road Over Bridge at Mangalagiri on June 17

THE SOUTH INDIA TIMES, VISAKHAPATNAM: The foundation stone for the Road Over Bridge (ROB) proposed at Mangalagiri under the Guntur Railway Division will be laid on June 17, 2026 (Wednesday). The ROB will be constructed in place of Level Crossing No.14 at Mangalagiri. Dr. Pemmasani Chandra Sekhar, Hon'ble Union Minister of State for Rural Development and Communications, Government of India, and Shri Nara Lokesh, Hon'ble Minister for Human Resources Development, Information Technology, Electronics, Communications and RTG, Government of Andhra Pradesh, will participate in the programme as chief guests and lay the foundation stone. The event will also be attended by Shri Kandula Durgesh, Hon'ble Minister for Tourism, Culture and Cinematography and Guntur District In-charge Minister, Shri Nadendla Manohar, Hon'ble Minister for Food and Civil Supplies and Consumer

Affairs, along with several public representatives and senior railway officials.

Level Crossing No.14, located on the Namburu-Mangalagiri main railway route in Guntur Division, is popularly known as the Mangalagiri Gate. A large number of motorists travelling between Mangalagiri and Amaravati use this route, leading to frequent traffic congestion. To facilitate hassle-free movement for the public and to ensure uninterrupted road and rail transportation, a Road Over Bridge will be constructed at this level crossing at an estimated cost of Rs.142 crore, entirely funded by the Railway Department. Upon completion of the ROB, both road and rail transportation are expected to become significantly smoother. The project will provide seamless connectivity to the State Capital, Amaravati. The travel distance and time between Mangalagiri and Amaravati are expected to reduce considerably, and the project is also anticipated to contribute to the region's social and economic development, railway officials said. The Road Over Bridge, which is set to become a crucial infrastructure project for the development of the State Capital Region, will not only enhance public transportation facilities but also strengthen infrastructure to meet future requirements.
