

All East Champaran police stations to have modern mess facilities soon

Motihari: East Champaran superintendent of police Swarn Prabhat has directed all police stations in the district to set up high-tech mess facilities with modern dining arrangements. The facility will be only for jawans and officers living in barracks, while those staying with families have been excluded.

The SP said the initiative aims to improve the quality of life and overall functioning of police personnel. "Jawans will get regular, nutritious and quality food, which will help them stay healthy and perform duties more effectively," he said.

According to inputs, many personnel were facing difficulty in cooking food or arranging rations on time due to long and irregular duty hours. The mess system is expected to address these issues and reduce delays in reporting for duty. It will also

minimise risks linked to the use of heaters and LPG cylinders in barracks.

In another administrative move aimed at making policing more effective and accountable, the district police have launched a monitoring initiative following directions from po-

lice headquarters. Twelve key police stations will be supervised closely by senior officers.

As part of the exercise, 12 top district officers, including the SP, have been assigned to oversee improvements in police station functioning, faster disposal of pending cases and enhanced public service delivery.

The SP said around 1,615 cases are currently pending across police stations in the district. During a recent inspection of the Town police station, he reviewed pending cases related to murder, loot, robbery, NDPS Act, SC/ST atrocities, attacks on police and prohibition law violations.

Biometric staff played key role in BPSC paper leak cases: DIG

Patna: Bihar Police's Economic Offence Unit (EOU) said on Friday that it has arrested a total of 37 people in connection with paper leak cases linked to two examinations conducted by the Bihar Public Service Commission (BPSC) in March this year.

DIG, EOU, Manoj Singh Dhillon, said that 35 arrests were made in the assistant education development officer (AEDO) examination paper leak matter. He said the EOU has recommended to the BPSC that the biometric company M/s Sai Educare Private Ltd, Jaipur, be blacklisted, after the investigation indicated large-scale involvement of its staff.

He also said two persons were arrested in connection with the assistant public sanitary and waste management officer (APS&WMO) examination paper leak case. In case in this regard has been registered at the SK Puri police station in Patna.

The AEDO examination took place from March 14 to 21 this year, while the APS&WMO ex-

ment, such biometric personnel were assigned duty and were made available to the BPSC, who were not even included in the list," the DIG pointed out.

He added that, out of eight cases registered in the AEDO paper leak issue, the EOU is investigating five cases filed at police stations across five districts: Munger, Nalanda, Vaishali, Begusarai and Nawada.

The EOU recently convened a meeting with the chairpersons of all service commissions, and shared advisories with them so that suitable corrective steps could be taken to stop such incidents in future.

Singh said, "In order to ensure smooth management of various competitive examinations scheduled in the near future, such as NEET-UG 2026 re-examination and the Constable Recruitment Examination, action is being taken by establishing a special cell at the EOU level for preventive surveillance, monitoring the current activities of previously accused individuals, and gathering intelligence inputs," Singh said.

North Koel project faces fresh delay over compensation issue

Gaya: The North Koel Canal Project is likely to be further delayed as landowners are putting obstacles in the project's execution.

According to official sources, about 30% of the land owners of Gaya district have refused compensation money on the ground that it was much below the market price. Land price, it may be recalled, has registered a sharp shoot up in recent years.

Confirming refusal of a section of the farmers/landowners to part with their land, Gaya district land acquisition officer Ravindra Ram said efforts were being taken to neutralise the impact of resistance of the land owners.

The govt has now taken possession of the land and it is being handed over to the water resources department (WRD). The compensation amount of the reluctant farmers is being deposited with the competent authority. As the court has not stayed the land acquisition proceeding, the land, as per law, is deemed to have been acquired.

Aurangabad officiating DM Anugrah Narain Singh told this newspaper on Friday that some land acquisition

tion related issues also exist in Aurangabad but the exact quantification of land yet to be fully acquired can not be made instantly. About 70% of the project work has been completed, he said.

Being monitored at high levels, including PMO and the state govt, the project missed the March 31 deadline. According to a senior WRD officer, no new deadline has been fixed for the project's completion. The project was started way back in 1972 and was subsequently stopped for envi-

ronmental reasons as it was feared that the dam height would pose threat to Palamu Tiger Reserve. The work got revived in 2017 only after the dam height was lowered to address the concerns of the Palamu Tiger Reserve. The water source of the project lies in neighbouring Jharkhand state.

The project cost too, in the meantime registering a steep hike. Estimated to cost only Rs30 crore in 1972, it is now estimated to cost a whopping Rs2,430 crore.

Once completed, the canal would irrigate about 1,25,000 hectares of land in the drought-prone Gaya and Aurangabad districts of Magadh division with Aurangabad being the major beneficiary. The canal will irrigate 95,000 hectares of land in Aurangabad while another 30,000 hectares of land in Gaya will receive the benefit.

Non-conventional construction techniques are being adopted to minimise water waste by making the canal bed and side slopes non porous. The technique, besides improving hydraulic efficiency, prevents soil erosion and increases flow velocity of irrigation water, said domain experts.

Applications are invited from the eligible candidates for the selection of Chairperson and two Members of Delhi Electricity Regulatory Commission (DERC).

Qualifications:

The Chairperson and Member of the Delhi Electricity Regulatory Commission shall be a person of ability, integrity and standing who has adequate knowledge of and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.

Additional and essential requirement of Legal/Judicial Member:

As per judgment dated 12.04.2018 of the Hon'ble Supreme Court of India in Civil Appeal No.14697 of 2015 titled "State of Gujarat & Ors. Vs. Utility Users' Welfare Association & Ors.", wherein it has been held that it is mandatory that there should be a person of law as a Member of the Commission. For this purpose, the candidate should be:

- a person who is or has been holding a judicial office; or
- an advocate with not less than ten years' practice and qualified for appointment as a Judge of a High Court under Article 217(2) of the Constitution of India; or
- an advocate with not less than seven years' practice and qualified for appointment as a District Judge under Article 233(2) of the Constitution of India.

Terms and Conditions of service of Chairperson and Members:

- The Chairperson and two Members shall hold office for a term of five years from the date on which he enters upon his office or till he attains the age of 65 years which ever is earlier. The Chairperson or other Member in the State Commission shall not be eligible for re-appointment in the same capacity as the Member in that Commission in which he had earlier held office.
- The salary, allowances and other terms and conditions of service of the Chairperson and Members in DERC shall be governed as per Section 89 of the Electricity Act, 2003 read with Delhi Electricity Regulatory Commission (Salary, Allowances & Other Conditions of Service of the Chairperson & Members) Rules, 2001 (as amended from time to time).
- The Chairperson and Member shall receive a pay of Rs.2,25,000/- (Rupees Two Lakh Twenty Five Thousand) (fixed) per month provided that in case a person appointed as Chairperson and Member is in receipt of any pension, the pay of such person shall be reduced by the given amount of pension drawn by him.
