Only after having sufficient EMD in his Wallet, the interest bidder will be able to bid on the date of e-auction.

9. Bidder's Global Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding.

10. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of **as mentioned for each property** to the last higher bid of the bidders. 5 minutes' time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of 5 minutes to the last highest bid, the e-auction shall be closed.
