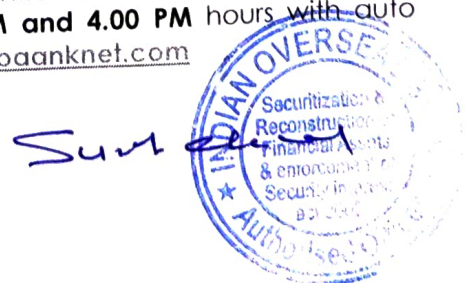

1. This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.
2.
