The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions.

1. The auction sale will be "online through E-auction" portal <https://baanknet.in> the intending Bidders / Purchasers are requested to register on portal (<https://baanknet.in>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders / Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet by **29.06.2026 up to 15.00 pm in the portal**. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.
