all such cables and prepare a detailed report. "I've referred the matter to the state govt for stringent action against the culprits," the DM said, adding that the victims' kin would receive compensation from the electricity department.

Meanwhile, Manoj Kumar, superintendent engineer at UP Power Corporation Limited, said that he has set up a panel to be led by the executive engineer of Purnapur circle to look into the allegations of "laxity and negligence".

According to his family, Mohd Amjad, a truck driver, had returned home to Asara village during Eid and stayed back to take care of his mother, Rukhsana. His younger brother, Mohsin, said the house's electricity supply had been disconnected in 2023 due to outstanding dues. He added that since then, a junior engineer had arranged a temporary power supply and had been taking Rs 1,000 every month. "On June 3, he disconnected the temporary supply and demanded that the entire outstanding amount be paid right away. When we requested some time, he misbehaved with us in front of neighbours," Mohsin said, adding that upset by his action, Amjad killed himself. "He was found hanging from a ceiling fan the next morning."

Mohsin added, "Our mother is an asthma patient and her condition started to worsen after the electricity was disconnected in this hot weather."

Baghatpur SU Raj Rai said, "Allegations made by the family are being examined."

The power department denied any link between their action and Amjad's death. Executive engineer Brijesh Kumar Yadav said the consumer had dues of around Rs 29,000 and that "repeated notices had been issued over the years". **Rahul Singh**

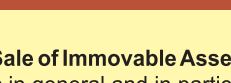

The complainant alleged that Singh had abused him and threatened to kill him during a dispute. Following a probe and subsequent chargesheet, Singh's case records were separated from the other accused, and his trial proceeded, clocking one year after the other.

For nearly three decades, Singh faithfully attended numerous hearings. Recently, though, after failing to appear in court due to an ailment, an arrest warrant was issued against him, with a notification that called for his properties to be attached.

Following the sentence, Singh said, "I am 80, and suffer from a host of health issues. Traveling to court and attending hearings was becoming tougher with every passing year. I thank the court for finally ending this matter. It's a tremendous relief for me and my family."
