

Pradhan orders foolproof security for NEET

New Delhi: Stricter digital tracking systems, tighter confidentiality protocols for question paper handling, randomisation mechanisms, enhanced police supervision during transportation and storage of examination material, and real-time coordination with district administrations formed the centrepiece of a high-level review meeting chaired by Union education minister Dharmendra Pradhan Tuesday ahead of the June 21 NEET-UG re-examination.

The ministry has set a 20-day window for the NTA to spruce up the system to deliver an enhanced secured test.

The meeting, attended by senior officials from the ministry of education, NTA, CBSE, Kendriya Vidyalaya Sangathan and Navodaya Vidyalaya Samiti, carried out a detailed stage-by-stage review of the entire examination chain following the paper leak controversy that forced cancellation of the earlier test.

"Every vulnerability identified in the earlier process must be comprehensively plugged. The re-examination has to be conducted in a secure, seamless and foolproof manner under stringent security protocols," Pradhan told TOI after the meeting.

According to officials present, discussions covered every operational layer — from empanelment and vetting of subject experts to question paper preparation, printing, packaging, dispatch, centre-level security, frisking protocols, storage arrangements and the return movement of OMR sheets back to NTA.

A significant part of the discussions focused on the process of selecting and handling question paper setters and moderators. Officials deliberated on stricter background verification, limited-access systems, compartmentalisation of paper-setting

work, enhanced confidentiality agreements and tighter digital isolation protocols to reduce the possibility of leaks at the source. The meeting also discussed minimising the number of individuals with access to the final paper compilation and increasing monitoring during the moderation and encryption stages. Deliberations took place on reducing human intervention at sensitive stages, introducing tighter digital logging systems for movement of confidential material, restricting access to printing and packaging zones, and creating multiple verification layers before question papers reach centres.

Meta, Google to curb fake NEET posts before re-test

Govt Holds Meet With Top Social Media Companies

New Delhi: Centre on Wednesday enlisted the support of major social media platforms, including Meta, Google and Telegram, to crack down on rumours, fake paper leak claims and panic-inducing posts ahead of June 21 NEET-UG re-examination, as govt steps up efforts to restore confidence in the country's biggest medical entrance test after the recent paper leak controversy.

Union education minister Dharmendra Pradhan chaired a high-level meeting with representatives of the social media companies and separately reviewed security preparations with central intelligence and law enforcement agencies, directing a "focused crackdown" on organised misinformation networks operating online before exams.

According to education ministry officials, concerns were raised over the growing spread of fake content through Telegram channels, anonymous groups and automated bots that become highly active before major exams. Officials said many such channels circulate fabricated paper leak claims, clickbait messages and unverified information designed to trigger panic and confusion among students and parents.

"Several suspicious channels were found to be operating through a limited set of phone numbers, indicating coordinated and organised activity," a senior ministry official

said, citing inputs shared by intelligence agencies during the meeting.

It is learnt that the social media platforms assured govt of proactive cooperation in identifying, blocking and removing misleading content linked to examinations, officials said. Pradhan directed the companies to work closely with the ministry National Testing Agency (NTA) and law enforcement agencies to ensure swift takedowns of channels spreading "fake information, propaganda and panic".

Officials said intelligence and security agencies were also asked to strengthen digital surveillance and monitor emerging online patterns in the run-up to the examination. Special attention is being given to encrypted messaging platforms and rapidly expanding groups that claim to provide advance access to

examination material or "inside information" to candidates.

The re-examination was announced after the cancellation of the May 31 test following allegations that parts of the paper had been leaked. The controversy revived concerns over exam security after earlier NEET-related disputes involving paper leak allegations, grace marks controversies and organised malpractice networks.

In Tuesday's review meeting on re-NEET preparations, Pradhan stressed that all vulnerabilities must be comprehensively addressed. Officials were instructed to hold coordination meetings with district magistrates and superintendents of police across states to ensure robust monitoring and strict implementation of security protocols at exam centres.

5 accused in NEET case sent to judicial custody

New Delhi: A Delhi court Wednesday sent five accused in the NEET paper leak case to judicial custody till June 2 and extended the CBI custody of another accused.

Special Judge Ajay Gupta allowed the agency's plea seeking judicial custody till June 2 of five accused persons — Mangilal Khatik, Vikas Biwal, Dinesh Biwal, all three arrested from Jaipur; Yash Yadav, arrested from Gurugram; and Dhananjay Lokhande, arrested from Ahilyanagar in Maharashtra. Judge Gupta also allowed five more days of custodial interrogation of another accused, Shubham Khairnar.

The agency said Khairnar needed to be further examined to identify and apprehend other co-accused persons to whom he had sold the NEET-UG 2026 papers, besides recovering and analysing digital devices and evidence, including communication records and financial trail connected to the "paper leak network". Meanwhile, Wednesday, the federal agency also sought signature specimens of accused Manisha Mandhare and Shivraj Motegaonkar.
