Mr. Pritesh Mukund Dondelkar and one had availed Mortgage facilities mentioned above from Indian Bank, Rawet Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Pritesh Mukund Dondelkar and one had failed to pay the outstanding dues to the Bank. 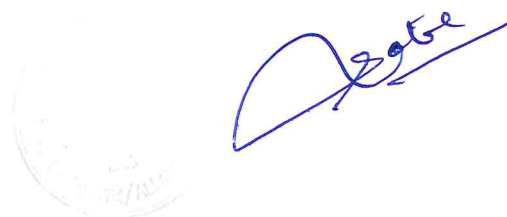

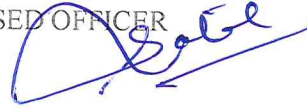
