POCSO case: HC eases travel curbs on BSY

Former Karnataka Chief Minister B.S. Yediyurappa has secured a significant relief from the Karnataka High Court in the POCSO case pending against him, with the court relaxing a bail condition that limited his travel outside its jurisdiction. The High Court passed the order after considering a petition filed by Yediyurappa seeking modification of the conditions imposed while granting him bail. He had requested the court to remove the requirement of obtaining prior permission before travelling outside the jurisdiction, citing practical difficulties in discharging his political responsibilities. After hearing the matter, the court agreed to relax the condition. As a result, Yediyurappa can now undertake travel across the country without obtaining prior approval from the court each time he leaves the jurisdiction.
