M/s UPPALA INDANDE AGENCIES have availed facilities from Indian Bank, Kasargod Branch, the repayment of which is secured by mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s UPPALA INDANDE AGENCIES failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 02-07-2019 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrowers, Guarantors of M/s UPPALA INDANDE AGENCIES liable to the Bank to pay the amount due to the tune of **Rs. 34,44,121/- (Rupees Thirty-Four Lakhs Forty-Four Thousand One Hundred Twenty-One only)** as on 01-07-2019 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 02-07-2019

As M/s UPPALA INDANDE AGENCIES failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 31-10-2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.
