

FINAL DEAL | Qatari, Pakistani officials to join negotiations; JD to attend meet

Vance: Witkoff & Araghchi in Switzerland for US-Iran talks

Washington: US Vice President JD Vance said on Saturday the peace talks with Iran were on and negotiators **Steve Witkoff** and **Jared Kushner** (R) were in Switzerland. Vance told Fox News he planned to join the talks in the next few days.

“We’ll plan the talks when the principals from the Iranian government, and also the Qatari and Pakistani governments, arrive. That may happen as soon as tomorrow, but these things are always a little bit in flux,” Vance said.

Jared and Steve have been on the ground now for a few hours, dealing with some of the technical elements of this negotiation,” Vance added.

“My understanding, talking to Jared and Steve this Saturday morning, is things are



going well,” Vance said.

“What a lot of the criticisms of the deal have really under-appreciated is that the US has all the cards. The Iranian military is destroyed. The Iranians have committed to destroying that stockpile of enriched material,” he said. “But we have economic pressure on the Iranians we would be willing to relieve if they do what we need them to do. If they don’t, there’s no skin off our back.” —PTI

Pak’s Naqvi in Iran; first high-level visit after initial pact

Islamabad: Pakistan Interior Minister Mohsin Naqvi arrived in Iran on Saturday, marking the first visit by a senior Pakistani official since Washington and Tehran signed an agreement aimed at restoring peace in West Asia.

Naqvi reached Mashhad on Saturday, Geo News reported.

Mashhad is one of Iran’s most important religious pilgrimage centres. Naqvi was likely to pay a spiritual visit to shrines in the city before travelling to Tehran later in the even-

ing. In the capital, he was likely to hold talks with senior Iranian officials.

According to the state-run IRNA news agency, Naqvi will “monitor the ongoing negotiations” between Iran and the US during his visit. Naqvi and Araghchi were expected to travel together to Switzerland, sources said.

Islamabad did not officially announce Naqvi’s visit, but he is expected to discuss upcoming technical-level talks between Washington and Tehran. —Agencies



US vice-prez blames Pakistan delay in releasing agreement

US Vice President **JD Vance** has blamed Pakistan’s press environment for a delay in releasing the full text of the recent US-Iran agreement.

Speaking on the podcast Interesting Times with Ross Douhat, Vance said the US had intended to release the agreement on June 15 but did so only on June 17.

“We actually wanted to get it out. Part of the misalignment here is in the Pakistani and Qatari systems, they don’t quite have



the First Amendment and freedom of the press,” Vance said.

He added unlike in the US, there is no expectation in Pak that such documents will be released for public scrutiny.

“There isn’t this expectation that the text is going to be out there for the Americans to actually probe and look at and analyse and understand for themselves. But it will be out,” Vance said. His remarks came amid criticism from Democrats over the administration’s decision to withhold the text of the Memorandum of Understanding (MoU) for two days after US President Donald Trump announced the interim agreement on June 15.

Soviet leader’s kin fights for Russia, captured by Ukraine

Ukrainian forces have captured **Anton Milaev**, the 45-year-old adopted great-grandson of former Soviet leader **Leonid Brezhnev**, Babel reported on June 19. He was captured while fighting as part of the Russian military.

The high-profile capture was initially reported by Russian media channels and subsequently corroborated by sources within Ukraine’s Coordination Headquarters for the Treatment of Prisoners of War, Babel reported.

Milaev, the adopted grandson of Brezhnev’s daughter Galina, signed a military contract with



the Russian Armed Forces in autumn 2025 and was deployed to the front lines as a combat sapper, according to Babel. Shortly after his deployment, the 45-year-old ceased all communication with his relatives in Nov 2025. His family received notification Milaev is being held as a prisoner of war in the Ukrainian-controlled sector of the southern Kherson region.
