Mrs. Madhabi Roy and Mr. Arun Kumar Roy availed IB Home Loan facility from Indian Bank, Kolkata - B K Pal Avenue Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. Madhabi Roy and Mr. Arun Kumar Roy failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 13.02.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s), Mrs. Madhabi Roy and Mr. Arun Kumar Roy liable to the Bank to pay the amount due to the tune of **Rs. 22,84,303/- (Rupees Twenty-Two Lakh Eighty-Four Thousand Three Hundred Three only)** as on 13.02.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 13.02.2026.

As Mrs. Madhabi Roy and Mr. Arun Kumar Roy failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 16.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 13.02.2026 is **Rs. 22,84,303/- (Rupees Twenty-Two Lakh Eighty-Four Thousand Three Hundred Three only)** with further interest, costs, other charges and expenses thereon from 14.02.2026.
