"The accused has been identified as Akshay Malviya, an Indore resident," DCP Rajesh Tripathi said. Preliminary investigations indicate he has already duped around 30 to 35 aspirants, collecting money through UPI and other digital payment gateways.

Paper leak video fake, hunt on for its creators: NTA

New Delhi: Dismissing as fake a viral video claiming the June 21 NEET-UG retest question paper had been leaked on the Telegram app, Centre and National Testing Agency (NTA) Monday initiated action to trace those who created and circulated it.

Press Information Bureau's Fact Check Unit said reports alleging a leak before Sunday's exam were "unfounded and false". The video—circulated widely across social media platforms—purportedly showed that the question paper was available on Telegram before the test.

NTA said manufacturing and deliberately circulating misinformation to defraud or alarm students was a serious offence. It is working with Indian Cyber Crime Coordination Centre (I4C) to identify those responsible for the content.

NTA director general Abhishek Singh said no complaint of a question paper leak had been received. A few attempts of forged admit cards, impersonation were detected and stopped, he added. TNN

At NTA's HQ, 250 Observers Tracked Feeds, Alerts in Real Time

New Delhi: Long before candidates reached NEET-UG exam centres Sunday, the day's first feeds were already streaming into NTA's Okhla headquarters, where, sources said, around 250 observers had taken their places. From there, they—with the help of AI tools—watched exam rooms, tracked biometric verification and responded to alerts from a network spanning 551 Indian cities and 14 overseas locations.

This was the nerve centre of an exam involving nearly 22.8 lakh candidates, 5,440 centres and more than 95,000 exam rooms—the apex of a monitoring system extending through the education ministry, 34 centrally funded institutions, state-level control rooms and district collectorates.

No group of observers could continuously watch every frame from the 1,38,560 CCTV cameras installed across centres. The system, therefore, combined human surveillance with AI tools that scanned feeds and flagged unusual movement or possible violations. Virtual observers could switch to a centre, examine its live feed and pass an alert down the chain for verification and action.

The multi-tier structure was meant to prevent Okhla from becoming the only point of response. Ahead of the exam, NTA director general Abhishek Singh said the

agency was working with "all stakeholders concerned", including district coordination committees headed by DMs, state police and intelligence agencies, to ensure smooth conduct.

The cameras were only one part of the picture reaching headquarters. Centre-level officials reported whether gates had opened on time, candidates had cleared frisking and biometric checks, jammers were functioning and the examination had begun as scheduled. Updates moved through dashboards, telephone lines and designated officials.

A centre systems officer was stationed at each venue to keep its cameras and technical systems working. Around 6,700 physical observers were deployed, while biometric personnel, invigilators, police and district officials formed

the on-ground response network. An alert noticed remotely could be checked by the observer or systems officer at the centre and escalated to district or state authorities.

NTA described the exercise as a "whole-of-govt effort" involving around seven lakh officials, including police, observers and examination staff. "Team Bharat," was how the agency characterised the network of central ministries, state govts, security forces, banks and technical agencies assembled for the test. The scale was closer to an election operation than a conventional entrance examination. NTA deployed 51,311 signal jammers, 38,795 frisking personnel and 48,448 workers for biometric verification and face authentication. Two invigilators were assigned to each room. On average, 40 to 50 security personnel were positioned at every centre.

New policy for evaluation of private CBSE students in Gulf countries: Centre to SC

New Delhi: The Centre Monday informed SC that CBSE has come up with a new policy for the evaluation of private students, who were affected by the cancellation of Class XII board exams in Gulf countries due to the Iran-US war.

Solicitor general Tushar Mehta told the SC bench that for the subjects for which exams could not be

held, the performance will be assessed based on the marks obtained by the private candidate in Class X and the last-attempted Class XII board exam. He said under the new policy, the marks would be computed as 40% of theory marks scored in the Class X board exam and 60% of theory marks scored in the last attempted Class XII board exam. PTI

NMC to end PG diploma courses, shift seats to MD/MS programmes

New Delhi: National Medical Commission (NMC) will end admissions to postgraduate diploma courses after 2026-27 academic year and convert existing seats into MD/MS programmes, aiming to bring all specialist medical training under a single degree framework.

NMC on Monday directed all medical colleges and institutions offering postgraduate diploma courses to apply for conversion of these seats into corresponding MD/MS seats through the Medical Assessment and Rating Board (MARB). It also clarified that 2026-27 will be the last academic year for admissions to PG diploma courses, following which such programmes will cease to function.

The move is expected to affect diploma seats across specialties such as Child Health, Obstetrics and Gynaecology, Anaesthesia, Ophthalmology, Psychiatry and Public Health currently offered by medical colleges across the country.

According to NMC, several institutions currently run both diploma and degree pro-

Patna: The police arrested at least 30 people for allegedly attempting irregularities in the NEET retest in Bihar, an officer said Monday.

While 18 people working in the exam centres were arrested for violating the biometric verification norms, the majority of the others were impersonators who tried to write the exam in place of the genuine candidates.

The retest was conducted across the state on Sunday amid tight security after the original undergraduate medical entrance test, held in early May, was cancelled amid widespread allegations of a question paper leak.

ADG (Law and Order) Sudhanshu Kumar said 18 staff members associated with the biometric verification system had been arrested for allegedly colluding with dummy candidates and middlemen by compromising the verification process.

According to a statement issued by Lakhisarai police, nine impersonators, a genuine candidate, and two associates were also apprehended.

Among the alleged impersonators were one fourth year MBBS student each from New Jalpaiguri Medical College (West Bengal), AIIMS Raebareilly (UP) and AN Magadh Medical College (Bihar), a first year student at Govern-

ment Medical College in Satna (Madhya Pradesh), an MBBS intern at University College of Medical Sciences in Shahdara (Delhi), a fourth year BPharma student at NMCH Patna, and another student at NMCH Patna.

Two of the impersonators were women—a BSc nursing student at BHU and a BAMS student at Government Ayurvedic College in Odisha. A genuine candidate, Sanjeet Kumar of Nalanda district, was also arrested for irregularities. Among the arrested biometric verification staff, three were supervisors and a fourth year MBBS student at PMCH Patna. The ADG said that two FIRs were lodged in Kiul and Kawayiya police stations of the district. ANI
