Borrower-Mortgagor Sri. Nemai Bairagya, S/o Bhutnath Bairagya 45/51/1, Botanical Garden Road, Botanical Gareden, Howrah-711103, availed credit facility from Indian Bank, **Botanical Garden Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr Nemai Bairagya, failed** to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **17.01.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) Mr Nemai Bairagya liable to the Bank to pay the amount due to the tune of **Rs. 6,02,555.00 (Rupees Six Lakhs Two Thousand Five hundred and Fifty-five only) as on 17.01.2026** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 17.01.2026.

As Mr. **Nemai Bairagya** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 11.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

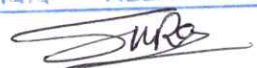

The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefore.
